Follow-up actions arising from the Report of the Commission of Inquiry into the Collision of Vessels near Lamma Island on 1 October 2012 (27 May 2013)</p>	<p>The Administration was requested to provide a written response to the following motion passed by the Panel:</p> <p>"就南丫島海難事件，調查委員會指出當局執法錯漏百出。本事務委員會對於運輸及房屋局局長及海事處處長遲來的道歉表示極度失望和遺憾。並促請當局必須以獨立及專業的原則進行調查及制度改革，違規官員應承擔責任。此外，政府應向海難死傷者家屬作出賠償。"</p> <p style="text-align: center;"><u>Translation</u></p> <p>"That, with regard to the marine disaster that happened near Lamma Island, the Commission of Inquiry pointed out that there were a lot of errors and omissions on the part of the authorities in taking enforcement actions. This Panel expresses its extreme disappointment with and regret for the belated apologies offered by the Secretary for Transport and Housing and the Director of Marine, and it urges the authorities to uphold the principles of independence and professionalism in conducting investigations and making reforms to the systems and that officials not performing their duties properly should be held responsible. In addition, the Government should provide compensation to families of those who died or were injured in this marine disaster."</p>	<p>The Administration updated the Panel on the follow-up actions taken at the meetings on 22 July &amp; 25 November 2013 and 24 March 2014 (LC Paper Nos.
