7. Extension of a supernumerary Administrative Officer Staff Grade C (D2) post holding the post of Assistant Commissioner for Tourism (4) (AC(T)4) in the Tourism Commission created up to 31 December 2014 for three years from 1 January 2015 to 31 December 2017

The AC(T)4 is responsible for providing policy input and co-ordination in promoting the development of cruise tourism in Hong Kong and for overseeing the development and operation of the Hong Kong Disneyland, including its future explanation plans. To sustain Hong Kong's position as a leading tourist destination, the Administration considers that there is an operational need to extend the post of AC(T)4 for three years from 1 January 2015 to 31 December 2017.

9. Overall planning of tourism infrastructures and relevant support measures

At the meeting of the Panel on Development on 14 October 2010, Hon Paul TSE cited the effort of the government of Singapore in the development of Sentosa into a tourist attraction and commented that the Administration should take the lead in the overall planning of tourism infrastructure in Hong Kong.

The Chairman of the Panel on Economic Development in the 2011-2012 session, agreed to include the item in this list as planning of tourism infrastructure is led by the Commerce and Economic Development Bureau.

The Administration has been requested to report on the progress

in developing new tourist attractions and, where appropriate, on measures being taken to address concerns about taxi scams, the operation of the SkyPier and the Security Bureau's Outbound Travel Alert System.

At the meeting on 16 October 2012, Hon CHAN Han-pan requested that the Administration should provide information on the development of ancillary facilities for the various tourist spots.

The Administration advised that it would include details of the relevant ancillary facilities when it briefed the Panel on individual tourism projects, e.g. the cruise terminal at Kai Tak, the Ocean Park and Hong Kong Disneyland projects.

10. Policies and measures for tackling anti-competitive activities to ensure a level playing field

Proposed by Hon Ronny TONG at the meeting on 28 November 2011. He was concerned about the widely reported incident in which large supermarket chains allegedly forced suppliers of beverage products to withhold their supplies to small retailers which sold these products to consumers at low prices. Panel members opined that there should be policies and measures for dealing with similar incidents and for ensuring a level playing field for large and small firms to conduct their business in Hong Kong. Members considered it necessary to invite the Administration as well as deputations from suppliers, retailers and the Consumer Council to a Panel meeting to give views in this regard.

11. Annual Report 2009-2010 of the Competition Policy Advisory Group

24. Implementing the National Twelfth Five-year Plan: Logistics Development

At the meeting on 28 March 2011, Hon Miriam LAU requested the Administration to brief the Panel on the implementation of the National Twelfth Five-year (12-5) Plan, in particular further development of Hong Kong as a shipping centre and logistics hub.

At the meeting on 13 October 2011, Hon Miriam LAU expressed concern about the slow progress in developing the logistics cluster in Kwai Tsing area as reported in the 2011-2012 Policy Address.

At the meeting on 16 October 2012, Hon Michael TIEN requested that the Administration should provide information on the comparison of the logistics facilities of Hong Kong and other cities in the Pearl River Delta.

(Note: The Administration has suggested that issues under this item be discussed after the findings of the Study on the Strategic Development Plan for Hong Kong Port 2030 and feasibility study for the proposed development of Container Terminal 10 at southwest Tsing Yi are available.)

25. Pilot scheme on cross-boundary sailing for pleasure vessels

29. Power supply and impact of fuel cost on electricity tariffs

Proposed by Hon Fred LI and Hon Emily LAU at the meeting on 28 May 2012 to examine the transparency of the mechanism of including the cost of natural gas in the adjustment of electricity tariffs, the ratio of natural gas for power generation, the natural gas supply, the carbon emissions standards which the two power companies had to meet, the Government's role in this regard, etc.

At the Panel meeting on 11 July 2012, Hon Emily LAU further proposed that the wider issue of power supply should be jointly examined by all relevant Panels in order that all associated factors, including the health impact of air pollution associated with power generation, could be examined holistically.

(Note: The Administration has advised that at the Panel meeting on 11 December 2012, members were provided with detailed analyses of the reasons for the 2013 tariff adjustment. At the meeting on 8 January 2013, members were briefed on the new Gas Supply Agreement of Castle Peak Power Company Limited. The Administration therefore proposed that the item be removed from the list.)

30. Operation of the local fuel market in a "fast price hike but slow price slash" manner

Proposed by Hon Starry LEE and Hon WONG Ting-kwong at the meeting on 13 October 2011. Hon WONG Ting-kwong, in particular, opined that the Administration should examine and explain whether the Competition Bill then under scrutiny could address concerns in this regard.

(Note: The Administration has advised that the Competition Ordinance was passed in June 2012 and that the Competition Commission has the power under the Ordinance to investigate into competition related complaints, and to bring public enforcement action before the Competition Tribunal. As the
