# Land Registry statistics for November

The Land Registry today (December 3) released its statistics for November 2013.

#### Land registration

- The number of sale and purchase agreements for all building units received for registration in November was 5,061 (+8.9% compared with October but -56.3% compared with November 2012)
- The 12-month moving average for November was 6,136 (8.1% below the 12-month moving average for October and 34.3% below that for November 2012)
- The total consideration for sale and purchase agreements in November was \$43.4 billion (+45.5% compared with October but -37.8% compared with November 2012)
- Among the sale and purchase agreements, 3,790 were for residential units (+10.6% compared with October but -46.1% compared with November 2012)
- The total consideration for sale and purchase agreements in respect of residential units was \$30.4 billion (+65.4% compared with October but -27.6% compared with November 2012)

The statistics only cover sale and purchase agreements with payment of stamp duty. Sale and purchase agreements relating to the sale of units under the Home Ownership Scheme, the Private Sector Participation Scheme and the Tenants Purchase Scheme are not included unless the premium of the unit concerned has been paid after the sale restriction period.

Figures on sale and purchase agreements received for the past 12 months, the year-on-year rate of change and breakdown figures on residential sales have also been released.

As deeds may not be lodged with the Land Registry until up to 30 days after the transaction, these statistics generally relate to land transactions in the previous month.

#### Land search

• The number of searches of land registers made by the public in November was 348,443 (-6.7% compared with October and -25.9% compared with November 2012)

The statistics cover searches made at the counter, through the self-service terminals and via the Integrated Registration Information System Online Services.



# The Land Registry Chart showing the number of Sale and Purchase Agreements of building units from November 2012 to November 2013


