# I. Proposal to establish a unified information and communications technology professional recognition framework in Hong Kong

(LC Paper No. CB(4)532/13-14(03) -- Administration's paper on establishing a unified information and communications technology professional recognition framework in Hong Kong

LC Paper No. CB(4)554/13-14(01) -- Administration's paper proposal to establish a unified information communications technology professional recognition framework in Hong Kong presentation (power-point material) (Chinese version only))

The Panel received views on the proposal to establish a unified ("ICT") information and communications technology professional Kong recognition framework in Hong from a total of Views were divided on the timing of establishment deputations/individuals. of the framework. Although the majority of the deputations/individuals attending supported the establishment of the framework in principle, many questioned the need for the hasty implementation of the framework which was not comprehensive. A summary of views expressed by the 55 deputations/individuals attending and the submissions received is in the **Appendix**.

### Welcoming remarks by the Chairman

2. <u>The Chairman</u> welcomed representatives of the Administration, Task Force on ICT Professional Development and Recognition ("Task Force") and deputations to the meeting. He reminded the deputations and the Task Force that, when addressing the Panel at the meeting, they were not covered by the protection and immunity under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382), and their written submissions were not covered by the said Ordinance. <u>The Chairman</u> then advised that as he had to attend the public hearing of the Public Accounts Committee which had clashed with this meeting, the Deputy Chairman would chair the remainder of the meeting on his behalf. <u>The Deputy Chairman</u> then took the chair in the absence of the Chairman.

# <u>Presentation by the Task Force on ICT Professional Development and Recognition</u>

- 3. <u>Professor Roland CHIN</u>, Convenor of the Task Force on ICT Professional Development and Recognition ("Task Force") said that the ICT industry in Hong Kong was beset with problems. For example, there was much room for improvement of the status or level of recognition of ICT practitioners in Hong Kong. Besides, the supply of ICT talents was insufficient and their professional standards varied. The Task Force aimed to rectify the above problems through the establishment of the proposed framework which would be in alignment with international practices and led by the ICT industry, the academia and the professionals.
- 4. <u>Ir Stephen LAU, non-official member of the Task Force</u> said that by raising the ICT professional profile of Hong Kong and providing a clear roadmap for ICT professionals, the proposed framework would be able to attract more young and talented people to choose ICT-related disciplines in their study and pursue ICT as their career.
- 5. <u>Ir Dennis PANG, non-official member of the Task Force</u> noted some of the deputations' views that the framework should focus on the principles of impartiality and neutrality, alignment with local and international ICT qualification and competency frameworks, as well as the participation by ICT practitioners and small and medium enterprises ("SMEs"). He stressed that such principles had been upheld by the Task Force since its establishment in November 2012. He added that the framework proposed to recognize ICT professional qualification schemes rather than individual professionals.

This multiple pathways approach not only helped ensure alignment on the assessment standards of different schemes, but also enabled practitioners to choose the schemes which best suited their career path. By making reference to existing well established local and international qualification frameworks, the proposed framework could more easily gain local and international recognition.

- 6. <u>Ir Dr George SZE, non-official member of the Task Force</u> said that apart from being a member of the Hong Kong Institution of Engineers ("HKIE"), he was also an ICT practitioner and an SME entrepreneur. Noting the view of some deputations that ICT practitioners were not represented in the Task Force, he stressed that many non-official members of the Task Force, including Ir Stephen LAU, Ir William LI and himself were ICT practitioners. Mr Daniel LAI, the Government Chief Information Officer, an official member of the Task Force, was also a veteran ICT practitioner before entering the Government.
- 7. <u>Ir William LI, non-official member of the Task Force</u> said that the proposed framework would require the professional qualification schemes to be recognized to put in place enforceable code of ethics and conduct to ensure the ongoing quality of the individuals. He added that the detailed design of the proposed framework was not finalized, and the Administration would conduct a two-month consultation from May to June 2014. Subject to the results of the public consultation and further refinements as necessary, the Administration's target was to launch the framework by the end of 2014.

#### **Discussion**

Timing of establishment of the proposed framework

- 8. Mr Charles Peter MOK declared that he was a member of the Task Force. He said that the proposed framework was long overdue and should not be further delayed, or left to the proposed Innovation and Technology Bureau to implement as suggested by some of the deputations. It was a misconception of some deputations that the proposed framework was introduced hastily and without consultation. In fact, the Task Force was only preparing for the public consultation which had yet to commence.
- 9. <u>Ir Dr LO Wai-kwok</u> said that as a former President of the Hong Kong Institution of Engineers, he regretted that although discussion on the establishment of a unified ICT qualification framework had already started a decade ago, it remained on the drawing board to date. With due respect for the hard work of the Task Force, he opined that the Administration should avoid further procrastination on the proposed framework, and consider the

establishment of a statutory body with legal backing and power, similar to the statutory Engineers Registration Board, to oversee the framework as a matter of urgency.

- 10. While expressing support for the development of the ICT industry in Hong Kong, Ms Emily LAU noted with concern the divergent views from deputations regarding the establishment of the proposed framework. She invited the deputations' suggestions on the way forward. Sharing a similar view, Mr SIN Chung-kai said that the proposed framework had to be established in Hong Kong first in order to enable alignment with local and international ICT qualification frameworks.
- 11. <u>Mr CHEUNG Chor-ping</u> of Jardine OneSolution (HK) Limited said that it was necessary for the Administration to take the first step to establish the proposed framework.
- 12. <u>Mr Francis CHAN</u> said that the Administration should treat ICT industry as a creative industry, and provide a favorable environment for the ICT industry to flourish.
- 13. <u>Mr Erwin HUANG</u> of the Hong Kong Information Technology Federation said that the establishment of the proposed framework was important for the long term development of the ICT industry in Hong Kong.
- 14. <u>Dr Johnny IP</u> of the Hong Kong Software Industry Association said that the Task Force should actively pursue the mutual recognition with Mainland ICT professional qualification schemes before pressing ahead with the establishment of the framework.
- 15. <u>Mr Wilson SHEA</u> of Hong Kong Small and Medium Enterprise Association said that the proposed framework was essential to the survival of SMEs which depended largely on the service provided by ICT professionals.
- 16. <u>Dr Witman HUNG</u> of the Internet Professional Association said that although he supported the establishment of the proposed framework, he considered that the proposed framework would not be a panacea for solving the multifarious problems facing the ICT industry. It was most important that the Administration should take the lead in adopting ICT. Moreover, care should be taken in the design of the governing structure so as to avoid being criticized for conflict of interest.
- 17. <u>Dr C K WONG</u> of iASPEC Technologies Limited said that it was a misunderstanding that the framework was proposed without prior consultation. In fact, discussion on the need for a unified professional ICT

framework had been going on at different levels for a number of years.

- 18. Mr Christopher CHUNG declared that he was a member of the Hong Kong Computer Society. He said that the Democratic Alliance for the Betterment and Progress of Hong Kong ("DAB") did not oppose to the establishment of the proposed framework. However, DAB was concerned about the hasty introduction of the proposed framework without thorough consultation, and the lack of a mutual recognition arrangement under the proposed framework. In this regard, Mr Stephen HO Chun-yin said that he opposed to the hasty introduction of the framework which was not comprehensive at this juncture. He also opined that the proposed framework should not be considered for implementation until the industry and the public had reached a consensus. Dr CHIANG Lai-wan, Mr YIU Si-wing, Mr WONG Ting-kwong and Mr NG Leung-sing shared a similar view.
- 19. Mr MA Fung-kwok enquired about the Task Force's plan on pursuing mutual recognition with local and international ICT qualifications. Ir Dennis PANG, non-official member of the Task Force responded that alignment would not be possible without the establishment of the proposed framework. The proposed framework would be the first step towards the establishment of a unified ICT professional recognition framework in Hong Kong by aligning with international practices. Upon successful implementation of the framework, the Administration would be able to proceed with exploring the possibility of mutual recognition of ICT professional qualifications with other major economies, including the Mainland.

Composition of the Task Force and the organization components for the proposed framework

- 20. Mr Steven HO Chun-yin noted that many members of the Task Force were members or former Chairmen of the Hong Kong Computer Society. He enquired how the Task Force could avoid being criticized for conflict of interest. Sharing a similar view, Mr YIU Si-wing opined that the ratio of professional members to lay members in the Assessment Committee and Appeal Panel should be balanced, and that the proposed framework should incorporate a consumer complaint mechanism.
- 21. <u>Ir William LI, non-official member of the Task Force</u> said that the Task Force only served as a preparatory committee for the establishment of the awarding body for the management, operation and on-going development of the proposed framework.

- 22. <u>Deputy Government Chief Information Officer (Consulting and Operations)</u> added that apart from members of the Hong Kong Computer Society, members of the Task Force consisted of members of other professional bodies such as the Hong Kong Institution of Engineers, the British Computer Society as well as individual ICT professionals.
- 23. <u>Professor Roland CHIN</u>, Convenor of the Task Force on ICT Professional Development and Recognition, hoped that the discussion should be focused on the proposed framework rather than on political issues and the protection of vested interests of different stakeholders. <u>Mr SIN Chung-kai</u> and Mr Charles Peter MOK shared a similar view.

#### Motion

24. <u>Mr Steven HO Chun-yin</u> proposed the following motion:

#### (Translation)

"That, as this Panel considers the Government's proposal to establish a unified information and communications technology ("ICT") professional recognition framework not comprehensive and has doubts about its effectiveness, the implementation of the proposal should be suspended.

That this Panel demands that the Government, prior to implementing a new ICT professional recognition mechanism, must carry out proper and extensive consultation with various sectors, draw up a policy on the future supply and management of ICT personnel, put forward specific operational and monitoring measures, as well as ensure that Hong Kong's ICT professional qualifications will be recognized in the Mainland and overseas."

25. <u>The Deputy Chairman</u> considered that the proposed motion was directly related to the agenda item under discussion. As no members disagreed to deal with the motion, the Deputy Chairman informed the

meeting that the motion would be proceeded with.

26. <u>Mr YIU Si-wing</u> proposed the following amendments to Mr Steven HO Chun-yin's motion:

#### (Translation)

"That, as this Panel considers the Government's proposal to establish a unified information and communications technology ("ICT") professional recognition framework not comprehensive and has doubts about its effectiveness, the implementation of the proposal should be suspended. consultation period should be extended to make way for a more comprehensive and extensive consultation exercise, and the proposal should not be considered for implementation until the industry and the public have reached a consensus.

That this Panel demands that the Government, prior to implementing a new ICT professional recognition mechanism, must earry out proper and extensive eonsultation with various sectors, draw up a policy on the future supply and management of ICT personnel, put forward specific operational and monitoring measures, as well as ensure that Hong Kong's ICT professional qualifications will be recognized in the Mainland and overseas."

27. The Deputy Chairman put the proposed motion as amended by Mr YIU Si-wing to vote. The Deputy Chairman announced that eight members, namely Mr WONG Ting-kwong, Mr Paul TSE, Mr NG Leung-sing, Mr Steven HO, Mr YIU Si-wing, Dr CHIANG Lai-wan, Mr LO Wai-kwok and Mr Christopher CHUNG voted for the motion and four members, namely Ms Emily LAU, Ms Cyd HO, Mr Charles Peter MOK, and Mr SIN Chung-kai voted against the motion. The Deputy Chairman declared that the motion was passed. The Deputy Chairman said that as the motion as amended had been passed, there was no need to vote on the original motion.
