#### I. Hospice care services

[LC Paper Nos. CB(2)1816/13-14(01), CB(2)1820/13-14(01) to (02), CB(2)1888/13-14(01) to (05), CB(2)1901/13-14(01) to (02), CB(2)1982/13-14(01), CB(2)2037/13-14(01) and CB(2)2084/13-14(01)]

<u>The Joint Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

2. <u>The Joint Subcommittee</u> requested the Administration to provide –

Admin

- (a) information on the additional funding for the two new contract residential care homes for the elderly, which had already commenced service tendering, for the provision of end-of-life care services for elderly residents and support to their carers; and
- (b) international benchmarks regarding the provision of palliative care beds and the number of patients with chronic or terminal illness who had passed away in hospitals in Hong Kong.

#### LegCo Secretariat

- 3. <u>The Joint Subcommittee</u> agreed that the Secretariat should write to the Administration to seek
  - (a) response from the Chief Secretary for Administration to members' request for the establishment of an inter-departmental committee under the purview of her office dedicated to formulate a comprehensive hospice care policy and coordinate the work of different bureaux/departments to improve the provision of hospice care for the needs of the ageing population; and
  - (b) response from the Secretary for Security to members' concerns regarding the application of the Hospital Authority's Do-Not-Attempt Cardiopulmonary Resuscitation Guidelines in an ambulance setting, and the factors and legal responsibilities that the Secretary would consider in deciding whether the Guidelines should be followed.
