WKCDA AWARDED AN ART PAVILLION TO BE BUILT ON THE CITY PARK SITE

Dear Mr. Christopher Chung and Members,

We checked the websites of both the WKCDA and the LEGCO Sub-Committee on WKCD Development and found the following announcements made in January:

- WKCDA has awarded the design the ART PAVILLION to be built on the CITY PARK SITE near the Kowloon harbourfront area. (Reference: WKCDA website on latest news, Jan. 2014).
- WKCDA presented to the LEGCO Joint SubCommittee on WKCD Development that they planned to turn the fully landscaped park envisaged in the "CITY PARK" Conceptual Plan into quality open space with a simple design, to facilitate early delivery of the Park in a costeffective manner. (Reference: LEGCO Sub-Com on WKCD Development website, Jan 21. meeting minutes).

We, HONG KONG ALTERNATIVES, find it shocking that this latest WKCDA's plan has completely reversed the original FOSTERS' design of a 19-hectares CITY PARK of 5000 trees, overwhelmingly accepted by the WKCDA, Government Bureau, Hong Kong media and public since mid-2011.

We are writing to you, as the Legco Joint Subcommittee to Monitor the Implementation of the WKCD Project to look into these changes and to protect the CITY PARK. According to the WKCDA's official figures, a budget of HK\$1 billion has been set aside for the CITY PARK development, \$23 million has so far been spent on a nursery of trees envisaged for the eventual planting on the Park (see attached SCMP article, Mid-2013). Unfortunately, as of to-date, the plot is still barren.

We sincerely hope that you will advise the WKCDA not to temper with the Fosters' CITY PARK conceptual chosen among the 3 finalists in 2011, we see this as your job to monitor their implementation of the WKCD CITY PARK Project development.
