Explanatory Note

Schedules 1 and 2 to the Pension Benefits Ordinance (Established Offices) Order (Cap. 99 sub. leg. J) list the offices which are established offices for the purposes of the Pension Benefits Ordinance (Cap. 99).

2. This Order amends the Schedules by including the following as established offices—
 - (a) Principal Veterinary Officer;
 - (b) Chief Regulatory Affairs Manager;
 - (c) Principal Regulatory Affairs Manager;
 - (d) Senior Regulatory Affairs Manager;
 - (e) Regulatory Affairs Manager;
 - (f) Secretary-General of the Film Development Council;
 - (g) Chief Apprenticeship Officer of the Vocational Training Council;
 - (h) Senior Apprenticeship Officer of the Vocational Training Council;
 - (i) Apprenticeship Officer of the Vocational Training Council; and
 - (j) Operation Assistant II of the Hospital Authority.

3. This Order also deletes from Schedule 1 the established office under the grade of Commissioner for Television and Entertainment Licensing.
