B	Amending the criterion for using the day on which the Legislative Council (“LegCo”) approves the proposed resolution as the basis for setting the commencement date (section (1)(b) of the proposed resolution)
C	Deleting the criteria for using the day on which FC or LegCo passes the relevant proposal as the basis for setting the commencement date (section (1)(a) and (1)(b) of the proposed resolution) and substituting a new commencement date
D	Amending the name of the relevant Bureau, Secretary and Permanent Secretary (section (1) and (2) and the Schedule to the proposed resolution)
