I. Meeting with the Administration

(LC Paper Nos. CB(3)797/13-14, LS77/13-14, CB(3) 87/14-15(02)-(05), File Ref: FHB/F/6/12/12, CB(3) 133/14-15(01)-(02) and CB(3) 214/14-15(01)-(02))

The Bills Committee deliberated and examined the Bill clause by clause (index of proceedings at **Annex**).

Follow-up actions arising from the discussion

- 2. <u>The Administration</u> was requested to provide the following information –
- (a) the terms of office of the Chairpersons and members, including elected and/or appointed members, of statutory bodies in Hong Kong;
- (b) the grounds for proposing the Chairperson and an appointed member of the Veterinary Surgeons Board ("VSB") to hold office for a term not exceeding three years and an elected member of VSB to hold office for a term of three years under the Bill; and the actual terms of office of VSB's Chairperson and members appointed since its establishment in 1997;
- (c) the respective timeframes within which a by-election must be held to fill a vacancy in the membership of the Legislative Council and District

- Councils; and the timeframe within which a by-election must be held to elect a member to VSB;
- (d) the estimated cost of holding an election of members to VSB; and
- (e) in connection with Clause 11 of the Bill under which the proposed new section 17A of the Veterinary Surgeons Registration Ordinance (Cap. 529) provides that VSB is to establish a panel of assessors consisting of not more than 12 registered veterinary surgeons ("RVSs") and not more than six other persons, whether there is a minimum number of RVSs and other persons to be appointed to the panel.

(*Post-meeting note*: The Administration's response to issues raised at the meeting on 2 December 2014 was issued to members vide LC Paper No. CB(3) 305/14-15(02) on 19 and 24 December 2014.)

Committee stage amendments ("CSAs") to the Bill

3. <u>The Chairman</u> suggested that members who intended to propose CSAs to the Bill should send their draft CSAs to the Clerk by mid-December 2014 for consideration by the Bills Committee at its fourth meeting. Members raised no objection.
