**Re: Human Reproductive Technology (Amendment) Bill 2015**

The Family Law Committee of the Law Society ("the Committee") has reviewed the Human Reproductive Technology (Amendment) Bill 2015.

The Committee notes that there is no exception under the proposed section 15(3A) which could otherwise allow the clinics offering gender selection services to those specifically sanctioned under Schedule 2 of the Human Reproductive Technology Ordinance (Cap. 561) to distribute the relevant materials and information to the legitimate service users.

In the light of the above, would the Administration please clarify if those clinics which distribute the relevant materials and information to the legitimate service users be viewed as in breach of the proposed section 15(3A)?
