LEGISLATIVE COUNCIL BRIEF

ELECTORAL LEGISLATION (MISCELLANEOUS AMENDMENTS) BILL 2015

INTRODUCTION

At the meeting of the Executive Council on 14 April 2015, the Council **ADVISED** and the Chief Executive **ORDERED** that the Electoral Legislation (Miscellaneous Amendments) Bill 2015 ("the Bill"), at **Annex A**, should be introduced into the Legislative Council ("LegCo").

2. The Bill makes technical amendments concerning the electorate of the functional constituencies ("FCs"), the name of an FC, counting procedures and textual errors for the 2016 LegCo election.

JUSTIFICATIONS

- 3. From 4 December 2013 to 3 May 2014, the Government conducted the Public Consultation on the Methods for Selecting the Chief Executive in 2017 and for Forming the LegCo in 2016 ("Public Consultation"). Among the views received, there are more views which consider that efforts should be focused on the proper handling of universal suffrage for the Chief Executive election in 2017; there could be no change to the method for forming the LegCo in 2016; and after the implementation of universal suffrage for the Chief Executive election in 2017, the community may focus on discussing how to attain the ultimate aim of electing all Members of the LegCo by universal suffrage as stipulated in Article 68 of the Basic Law.
- 4. On 31 August 2014, the Standing Committee of the National People's Congress adopted the Decision of the Standing Committee of the National People's Congress on Issues Relating to the Selection of the Chief Executive of the Hong Kong Special Administrative Region by Universal Suffrage and on the Method for Forming the Legislative Council of the Hong Kong Special Administrative Region in the Year 2016 ("the Decision"). According to the Decision, the existing formation method for the LegCo as prescribed in Annex II to the Basic Law will not be amended; and the formation method of the fifth term

LegCo will continue to apply to the sixth term LegCo in 2016. In other words, the sixth term LegCo in 2016 should continue to consist of 70 members: 35 to be returned by FCs and 35 by geographical constituencies ("GCs").

Technical amendments for FCs

Updating the electorate

В

- 5. In keeping with the established practice, and in consultation with relevant bureaux/departments, we have reviewed the delineation of the electorate of all the FCs under the Legislative Council Ordinance (Cap. 542) ("LCO"). On the basis of the review, we **propose** to make necessary technical amendments as set out at **Annex B**, whilst maintaining the existing delineation of the FCs concerned intact. The proposed amendments can be classified into the following categories
 - (a) to update the names of the bodies¹ which have had their names changed since the last updating exercise²;
 - (b) to remove bodies which have ceased operation since the last updating exercise;
 - (c) to improve the formulation of the definition of some electors;
 - (d) to add new electors to update the prevailing situation of the FCs concerned.
- 6. We consulted the LegCo Panel on Constitutional Affairs on 16 March 2015 regarding the proposed technical amendments, and the Panel did not raise objection to our proposals. After the meeting on 16 March 2015, we received a request from the Hong Kong Recording Industry Alliance Limited to include its members entitled to vote at its general meetings in the sports, performing arts, culture and publication FC. Having consulted the relevant bureau/department, we have included the proposed technical amendments in **Annex B**.

[&]quot;Bodies" in this paper refer to (a) "umbrella organisations", i.e., bodies for which their members (which may be natural persons, unincorporated or incorporated bodies) are electors; and/or (b) "listed bodies", i.e., bodies which are electors.

The last updating exercise was done in 2012 before the 2012 LegCo election.

Change in nomenclature of the architectural, surveying and planning FC

- 7. A Member raised at the meeting of the LegCo Panel on Constitutional Affairs on 16 March 2015 to also include in the name of the architectural, surveying and planning FC the landscape sector, so that the name of the FC should become the architectural, surveying, planning and landscape FC. The Member argued that it is a technical amendment to better reflect the existing composition of the FC (i.e., architects, surveyors, planners and landscape architects) without affecting the composition or the electorate of the FC. We **propose** that the request be acceded to, as it is a simple technical amendment without affecting the existing definition of the concerned FC's electorate.
- 8. For our proposals in paragraphs 5 to 7 above, we **propose** that corresponding amendments should also be made to the Schedule to the Chief Executive Election Ordinance (Cap. 569) ("CEEO") to reflect the corresponding changes to the name and electorate of, and the registration of voters for, the relevant Election Committee subsectors.

Other technical amendments (relating to counting procedures and textual errors)

- 9. In the light of the experience gained from previous elections, we **propose** to take the opportunity to make other technical amendments in the following respects
 - counting procedures for the District Council (second) FC (a) election: the provision detailing the counting steps at the central counting station under the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D) currently requires counting the number of District Council (second) FC ballot papers from each polling station and verification of the ballot paper account to take place before counting of votes. To remove possible procedural ambiguities and better align with the policy objectives to speed up the counting process and to protect secrecy of votes, we propose making amendments to make clear that –
 - (i) verification of the ballot paper account of a polling station (other than a small polling station ("SPS")³ or a dedicated

A small polling station is a polling station at which less than 500 electors are allocated to vote in a LegCo election.

polling station ("DPS")⁴) will be done after the counting of votes; and

(ii) for an SPS or a DPS, counting of the number of ballot papers and verification of the ballot paper account of that station will be done first. Such ballot papers will then be mixed with the ballot papers from a bigger polling station before counting of the votes. After completion of counting of votes, verification of the ballot paper account of that bigger polling station will be done.

The proposed procedures are similar to those in respect of main counting stations in a GC election, which have been implemented with LegCo's passage of the Electoral Legislation (Miscellaneous Amendments) Ordinance 2014 in July 2014; and

- (b) <u>rectification of textual error</u>: in the Chinese text of section 74AA(h) of Cap. 541D, "大點票站" instead of "點票站" should be adopted for "main counting stations".
- 10. The Members did not raise any objection to the above proposed technical amendments at the meeting of the LegCo Panel on Constitutional Affairs on 16 March 2015. Besides, we now **propose** to rectify one more textual error in the Chinese text of section 20E(b)(xi) of the LCO where "嶺南大學校董會成員" instead of "嶺南大學校董會" should be adopted for "members of the Council of Lingnan University".

THE BILL

11. The main provisions are summarised below –

- (a) **Part 1** sets out the short title of the Bill;
- (b) **Part 2** amends the LCO to update the electorate of certain FCs and the name of an FC;
- (c) **Part 3** amends the Schedule to the CEEO to update the list of constituents of the higher education subsector and the name of the architectural, surveying and planning subsector and introduce a technical amendment concerning the registration of

voters for the sports, performing arts, culture and publication subsector; and

(d) **Part 4** amends the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation to streamline the counting procedures for the District Council (second) FC at the central counting station and to make a textual amendment.

The existing provisions being amended are at **Annex C**.

IMPLICATIONS OF THE PROPOSAL

13. The legislative proposal is in conformity with the Basic Law, including the provisions concerning human rights. The proposed amendments will not affect the current binding effect of the Ordinances and subsidiary legislation which the Bill seeks to amend. The proposal has no financial, civil service, economic, productivity, environmental, sustainability or family implications.

PUBLIC CONSULTATION

14. The Government conducted the Public Consultation from December 2013 to May 2014. We consulted the LegCo Panel on Constitutional Affairs on our proposed legislative amendments on 16 March 2015, and the Panel did not raise objection to our proposals. At the meeting, individual Members called for abolition of some, if not all, of the FCs; or a large-scale expansion of the electorate of the FCs. In response to these comments, the Government explained that abolition of the FCs for the 2016 LegCo election was inconsistent with the Decision; there was no clear consensus in the community on making major amendments to the electorate of the FCs for the 2016 LegCo

election; and relatively substantial amendments had been made to the method for forming the LegCo in 2012, which greatly enhanced the democratic elements of the LegCo election. Hence, having regard to the actual situation in the Hong Kong Special Administrative Region, the Government only introduces technical amendments at this stage.

15. Besides, a Member raised that whether the legislation should be amended for the four special FCs which adopted the preferential elimination system of voting. The Member considered that in case there were only two candidates, and if an elector erroneously used a tick chop instead of marking his/her preference by entering Arabic numerals on the ballot paper as required by the law, the ballot paper concerned should not be regarded as invalid since the choice of the elector was obvious. We have thoroughly considered this comment, and are of the view that designing a separate system specifically for the two-candidate situation in the elections of these FCs will cause more confusion. The Government considers that strengthening the education of the electors in these special FCs about the correct voting method instead of amending the relevant legislation is more appropriate, and will follow up on this matter.

Part 2

Membership of Election Committee

2. How Election Committee is to be constituted

- (1) The Election Committee is to consist of 1200 members, who must be Hong Kong permanent residents. (Amended 1 of 2011 s. 9)
- (2) The membership of the Election Committee (other than ex-officio members) is to be determined in accordance with the procedures specified in this Schedule.
- (3) The members of the Election Committee are to be representative of 4 sectors, with each sector being represented by 300 members. (Amended 1 of 2011 s. 9)
- (4) The sectors are to be composed of the subsectors specified in Tables 1, 2, 3 and 4.
- (5) The composition of the subsectors is as follows—
 - (a) except in the case of the higher education and education subsectors, the social welfare subsector and the tourism and hotel subsectors, the composition of a subsector specified in Table 1, 2 or 3 which has the same name as that of a functional constituency is to be the same as that of the functional constituency;
 - (b) each of the subsectors specified in column 2 of Table 4 is to be composed of the persons described in column 3 of that Table in relation to the subsector;
 - (c) the Hong Kong Chinese Enterprises Association, tourism, hotel, Chinese medicine, higher education, education, Employers' Federation of Hong Kong and social welfare subsectors are to be composed as shown in Table 5; and
 - (d) the religious subsector is to be composed as described in Part 3.
- (6) Subject to subsection (7), for the purpose of constituting the Election Committee, each subsector is allocated the number of members specified in the relevant Table in respect of the subsector.
- (7) The Election Committee is constituted in the following manner—
 - (a) the number of members allocated to the religious subsector is to be nominated by that subsector in accordance with Part 3;
 - (b) subject to subsection (9), the number of members allocated to the subsectors specified in Tables 1, 2 and 3 (except those allocated to the religious subsector), and items 3, 4, 5 and 6 of Table 4 are to be elected by the relevant subsectors in accordance with Part 4; and
 - (c) subject to subsection (8), the number of members allocated to the subsector specified—
 - (i) in item 1 of Table 4 is to be filled by the persons holding office as Hong Kong deputies to the National People's Congress; and
 - (ii) in item 2 of Table 4 is to be filled by the persons holding office as the Members of the Legislative Council,

who are registered as ex-officio members of the Election Committee in, and whose names have not been removed from, the final register of members of the Election Committee.

- (8) Subject to section 41, the Electoral Registration Officer shall, in compiling an interim register of members of the Election Committee under section 40(1) after the publication of results of the subsector ordinary elections, register— (Amended 10 of 2006 s. 21)
 - (a) the persons holding office on the date of those subsector ordinary elections (or the last of those dates, if different dates are specified for those subsector ordinary elections) as Hong Kong deputies to the National People's Congress; and
 - (b) the persons holding office on the date of those subsector ordinary elections (or the last of those dates, if different dates are specified for those subsector ordinary elections) as the Members of the Legislative Council,

(except those persons who are not Hong Kong permanent residents) as ex-officio members of the Election Committee, in accordance with the EAC Regulations.

- (9) (a) Subject to paragraph (b), the number of members allocated to the sports, performing arts, culture and publication subsector is to be divided equally among the 4 sub-subsectors constituting that subsector, namely sports, performing arts, culture and publication sub-subsectors.
 - (b) If the number of members cannot be allocated equally as an integer, the sub-subsectors are to be allocated the largest possible integer, and the remaining number is to be allocated according to the number of voters of the sub-subsectors such that the sub-subsector having the greatest number of voters is allocated a seat first until all the seats are allocated.

 - (c) a person who is registered, or applies to be registered, as an elector for the sports, performing arts, culture and publication functional constituency by virtue of being a person described in section 20V(1)(d) or (e) of, or Part 2 of Schedule 1B or item 6, 7, 10, 11, 13, 14, 19, 20, 22, 26, 27, 31, 33, 35, 37, 38, 48, 53, 58, 61 or 62 of Part 3 of Schedule 1B to, the Legislative Council Ordinance (Cap 542) may be registered only as a voter for the culture sub-subsector; and
 - (d) a person who is registered, or applies to be registered, as an elector for the sports, performing arts, culture and publication functional constituency by virtue of being a person described in section 20V(1)(g), (h), (j) or (k) of, or item 15, 21, 28, 32, 36 or 51 of Part 3 of Schedule 1B to, the Legislative Council Ordinance (Cap 542) may be registered only as a voter for the publication sub-subsector. (Amended 7 of 2008 s. 10)
- (3) A person is eligible to be registered as a voter for the higher education subsector if the person—
 - (a) is a person described in section 20E(a), (aa) or (b) of the Legislative Council Ordinance (Cap 542) and has made an application to be registered for the education functional constituency; or
 - (b) is registered for the education functional constituency in the existing functional

constituencies final register, and is eligible to be registered as an elector for that functional constituency by virtue of being a person described in section 20E(a), (aa) or (b) of the Legislative Council Ordinance (Cap 542). (Amended 25 of 2003 s. 56)

- (4) A person is eligible to be registered as a voter for the education subsector if—
 - (a) the person is a person described in section 20E(c), (d), (e), (f) or (g) of the Legislative Council Ordinance (Cap 542) and has made an application to be registered for the education functional constituency; or
 - (b) the person is registered for the education functional constituency in the existing functional constituencies final register, and is eligible to be registered as an elector for that functional constituency by virtue of being a person described in section 20E(c), (d), (e), (f) or (g) of the Legislative Council Ordinance (Cap 542).
- (5) A person is eligible to be registered as a voter for the social welfare subsector if—
 - (a) the person is a person described in section 20M of the Legislative Council Ordinance (Cap 542) and has made an application to be registered for the social welfare functional constituency;
 - (b) the person is registered for the social welfare functional constituency in the existing functional constituencies final register, and is eligible to be registered as an elector for that functional constituency by virtue of being a person described in section 20M of the Legislative Council Ordinance (Cap 542);
 - (c) the person is a person described in paragraph (2), (3) or (4) of item 8 of Table 5 in section 2 and has made an application to be registered for the social welfare subsector; or
 - (d) the person—
 - (i) is registered for the social welfare subsector in the existing subsector final register by virtue of being a person described in paragraph (2), (3) or (4) of item 8 of Table 5 in section 2; and
 - (ii) is not disqualified from being registered as a voter for that subsector.
- (6) A person is eligible to be registered as a voter for the tourism subsector if the person—
 - (a) is a person described in section 20O(aa), (b) or (c) of the Legislative Council Ordinance (Cap 542) and has made an application to be registered for the tourism functional constituency; or
 - (b) is registered for the tourism functional constituency in the existing functional constituencies final register, and is eligible to be registered as an elector for that functional constituency by virtue of being a person described in section 20O(aa), (b) or (c) of the Legislative Council Ordinance (Cap 542). (Amended 25 of 2003 s. 56)
- (7) A person is eligible to be registered as a voter for the hotel subsector if—
 - (a) the person is a person described in section 20O(d) or (e) of the Legislative Council Ordinance (Cap 542) and has made an application to be registered for the tourism functional constituency; or
 - (b) the person is registered for the tourism functional constituency in the existing functional constituencies final register, and is eligible to be registered as an elector for that functional constituency by virtue of being a person described in section 20O(d) or (e) of the Legislative Council Ordinance (Cap 542).
- (8) A person is eligible to be registered as a voter for the Hong Kong and Kowloon District Councils subsector if the person is a person described opposite to that subsector in column 3 of Table 4 in section 2 and is eligible to be registered as an elector for the District Council (first) functional constituency. (Amended 1 of 2011 s. 11)
- (9) A person is eligible to be registered as a voter for the New Territories District Councils subsector if the person is a person described opposite to that subsector in column 3 of Table 4 in section 2 and is eligible to be registered as an elector for the District Council (first) functional constituency. (10) Subject to this section—

- (a) a person who is registered or applies to be registered as an elector for a functional constituency with the same name as a subsector, cannot, subject to paragraph (b), be registered only as an elector for that functional constituency and not as a voter for the subsector;
- (b) a person who is registered or applies to be registered as a voter for a subsector with the same name as a functional constituency, cannot be registered only as a voter for that subsector and not as an elector for the functional constituency;
- (c) a person who is registered, or has made an application to be registered, as an elector for a functional constituency with the same name as a subsector may be registered only as a voter for that subsector (whether or not the person is eligible to be registered as a voter for any other subsector), except that, if the person is eligible to be registered as a voter for any other subsector specified in item 3 of Table 4, or item 1, 4, 7 or 8 (by virtue of subsection (5)(c) or (d)) of Table 5, in section 2, the person may choose to be registered as a voter in the first-mentioned subsector or in that other subsector; and
- (d) a person who ceases to be eligible to be registered as an elector for a functional constituency with the same name as a subsector ceases to be eligible to be registered as a voter for that subsector, but may, subject to paragraph (a) and subsection (12), apply to be registered as a voter for any other subsector for which the person is eligible to be registered as a voter.

- (g) a person who is eligible to be registered as a voter for the Hong Kong and Kowloon District Councils subsector cannot be registered only as a voter for that subsector and not as an elector for the District Council (first) functional constituency; and (Added 1 of 2011 s. 11)
- (h) a person who is eligible to be registered as a voter for the New Territories District Councils subsector cannot be registered only as a voter for that subsector and not as an elector for the District Council (first) functional constituency. (Added 1 of 2011 s. 11)

- (14) A person who is registered, or applies to be registered, as an elector for the education functional constituency by virtue of being a person described in section 20E(c), (d), (e), (f) or (g) of the Legislative Council Ordinance (Cap 542) may be registered only as a voter for the education subsector.
- (15) A person who is eligible to be registered as a voter for both the education subsector and the higher education subsector, may only be registered as a voter for the higher education subsector.
- (16) A person who is registered, or applies to be registered, as an elector for the tourism functional constituency by virtue of being a person described in section 20O(aa), (b) or (c) of the Legislative Council Ordinance (Cap 542) may be registered only as a voter for the tourism subsector. (Amended 25 of 2003 s. 56)
- (17) A person who is registered, or applies to be registered, as an elector for the tourism functional constituency by virtue of being a person described in section 20O(d) or (e) of the Legislative Council Ordinance (Cap 542) may be registered only as a voter for the hotel subsector.
- (18) A person who is eligible to be registered as a voter for both the tourism subsector and the hotel subsector, may only be registered as a voter for the hotel subsector.
- (19) A person described in column 3 of Table 4 in section 2 in relation to the subsector specified in item 3 of that Table, who—
 - (a) is eligible to be registered as an elector under Part 5 of the Legislative Council Ordinance (Cap 542) for a geographical constituency and has made an application to be so registered; or
 - (b) is registered in the existing geographical constituencies final register, and is eligible to be, and is not disqualified from being, registered as an elector for a geographical constituency,
 - is eligible to be registered as a voter in that subsector.
- (20) A member of a body specified in item 1, 2, 3, 7 or 8 of column 3 of Table 5 in section 2 is not eligible to be registered as a voter for the relevant subsector, unless immediately

before that member applies for registration as a voter—

- (a) if the member is a corporate member of a body—
 - (i) that member has been a member of that body for at least 12 months; and
 - (ii) that member has been operating for at least 12 months; or
- (b) if the member is a natural person, the person has been a member of that body for at least 12 months.
- (21) A consular post to which any privilege or immunity is accorded under the Consular Relations Ordinance (Cap 557) is not eligible to be registered as a voter for any subsector. (Added 1 of 2011 s. 11)
- (22) An organization to which section 2 of the International Organizations and Diplomatic Privileges Ordinance (Cap 190) applies or an international organization defined in section 2 of the International Organizations (Privileges and Immunities) Ordinance (Cap 558) is not eligible to be registered as a voter for any subsector. - (3) If the Returning Officer considers it necessary or if required by a candidate, an election agent or a counting agent present at the counting zone, that Officer must, in preparing the verification of the ballot paper account, compare the ballot paper account with the number of ballot papers recorded by that Officer and the spoilt ballot papers, the unused ballot papers and the counterfoils or un-issued ballot papers.
- (4) The Returning Officer must give the receptacles referred to in subsection (2)(d)(v) or (e)(v) into the charge of an Assistant Returning Officer in attendance at the relevant counting zone. The Assistant Returning Officer—
 - (a) must hand over the receptacle containing the bundle of special functional constituency ballot papers to the Returning Officer for the relevant special functional constituency;
 - (b) must hand over the receptacle containing the bundle of other FC ballot papers to the

- Returning Officer for the relevant functional constituency; and
- (c) must hand over the receptacle containing the bundle of GC ballot papers to the Returning Officer for the relevant geographical constituency.
- (5) A candidate, an election agent or a counting agent may copy what is recorded on the ballot paper account or the verification of the ballot paper account.

The Presiding Officer of a ballot paper sorting station must—

- (a) sort the GC ballot papers in each ballot box under the Officer's charge according to each geographical constituency; (L.N. 73 of 2011)
- (b) count and record the number of GC ballot papers for each geographical constituency; (L.N. 73 of 2011)
- (c) verify the ballot paper account by comparing it with the number of GC ballot papers recorded under paragraph (b); (L.N. 73 of 2011)
- (d) prepare a statement in writing as to the result of the verification; (L.N. 73 of 2011)
- (e) prepare a statement in writing as to the number of GC ballot papers recorded under paragraph (b); (L.N. 73 of 2011)
- (f) make into separate bundles the sorted GC ballot papers together with the relevant statement prepared under paragraph (e); (L.N. 73 of 2011)
- (g) place each bundle in a separate receptacle and seal it in the presence of those present at the counting zone; (L.N. 73 of 2011)
- (h) arrange the receptacles to be delivered to the Presiding Officers of the respective main counting stations of the relevant geographical constituencies; and (L.N. 73 of 2011)
- (i) send to the Chief Electoral Officer the ballot paper accounts, verification of the ballot paper accounts and the sealed packets made up under section 63A. (L.N. 73 of 2011) (L.N. 130 of 2009)

- (1) At the counting zone for the District Council (second) functional constituency, the ballot papers for the constituency the number of which is recorded under section 74AAA(2)(a) and those handed over under sections 74(8)(b), 74A(3) and 74AB(3) must be dealt with by the Returning Officer as provided in this section.
- (2) The ballot papers are to be separated with reference to the list of candidates for which the vote has been recorded.

- (3) The votes recorded on the ballot papers are to be counted according to the system of counting described in section 49 of the Legislative Council Ordinance (Cap 542).
- (4) In the course of counting in accordance with subsection (3)—
 - (a) any ballot paper—
 - (i) which appears to have any writing or mark by which the elector can possibly be identified;
 - (ii) which appears to be not marked in accordance with section 55(2);
 - (iii) which appears to be substantially mutilated; or
 - (iv) which appears to be void for uncertainty,
 - is questionable and must be separated and forwarded to the Returning Officer or an Assistant Returning Officer to decide whether the vote is to be counted in accordance with section 81; and
 - (b) any ballot paper described in section 80(1)(b), (c), (d), (f), (ha) and (i) must be separated and the vote is not to be counted pursuant to section 80.
