**Re: ESCC3792/2014 – HKSAR v Fong Kwok Shan, Christine, Cheung Mei Hung and Fong Yu Ching**

We act for Ms. Fong Kwok Shan, Christine, Mr. Cheung Mei Hung and Mr. Fong Yu Ching, the 1<sup>st</sup> to 3<sup>rd</sup> Defendants respectively under the captioned criminal proceedings.

We write to seek leave from the esteemed Legislative Council under s.7(1), Legislative Council (Power and Privileges) Ordinance (Cap.382) to permit the following prosecution witnesses (particulars whereof are set out below), who are officers of the Legislative Council and will be called, to give evidence in the captioned criminal proceedings relating to the events happened in the public gallery before the Public Works Sub-committee of Legislative Council Finance Committee on 7<sup>th</sup> May 2014 and 13<sup>th</sup> May 2014:-

- (1) Ms. Li Yuk-wah (李玉華), Security Assistant I;
- (2) Mr. Liu Kam-wo (廖錦和), Security Officer; and
- (3) Ms. Chak Man-yuet (翟民悅), Security Assistant II.

Given they are prosecution witnesses, the basis why the prosecution is not required to seek leave is because the Defendants are able to agree to matter like, e.g. what the Chairman said during the meetings.

The prosecution has indicated to the Court that they do not oppose our application and agreed that given the width of s.7, the cross examinations of one or more of the above prosecution witnesses may touch on matters covered or arguably covered by s.7.

Please also be informed that the Court ordered the parties to report the progress of this application on 8<sup>th</sup> June 2015. The adjourned trial and cross examination of the .../P.2

第 382 章 立法會(權力及特權)條例

7. 未經許可不得就立法會或任何  
委員會的會議程序作證

(1) 如未經立法會特別許可，任何議員或立法會人員，以及受僱在立法會或任何委員會會議席上錄取會議紀要或保存證據紀錄的人，不得就上述會議紀要或證據紀錄的內容、或就提交立法會或任何委員會的文件內容(視屬何情況而定)、或就立法會或任何委員會所進行的會議程序或訊問(視屬何情況而定)，在其他地方作證。

(2) 在立法會休會或押後會議期間，第(1)款所提述的特別許可，可由主席給予；如主席因不在香港或喪失履行職務能力以致不能行事者，則可按照議事規則給予。

7. **Evidence of proceedings in the Council or any  
committee not to be given without leave**

(1) No member or officer of the Council, and no person employed to take minutes or keep any record of evidence before the Council or a committee, shall give evidence elsewhere in respect of the contents of such minutes or record of evidence, or of the contents of any document laid before the Council or committee, as the case may be, or in respect of any proceedings or examination held before the Council or committee, as the case may be, without the special leave of the Council.

(2) During a recess or adjournment of the Council, the special leave referred to in subsection (1) may be given by the President or, if the President is unable to act owing to his absence from Hong Kong or incapacity, in accordance with the Rules of Procedure. (*Amended 71 of 2000 s. 3*)
