I. Election of Chairman

After discussion, <u>members</u> agreed to invite representatives of the Central and Western District Council and operators of the Western District Public Cargo Working Area to meet with the Subcommittee at its next meeting to be held on 24 February 2015, at 8:30 am.

7. <u>Mr Tony TSE Wai-chuen</u> said that he had sent a reply slip to the Secretariat indicating his intention to join the Subcommittee, but his name was not included on the membership list of the Subcommittee. <u>The Chairman</u> requested the Clerk to look into the matter.
