002555 – 004737	Chairman Mr Albert CHAN Living Lamma WWF Living Islands Movement Administration	Discussion on the sources of refuse at beaches in Hong Kong and ways for the Administration to improve management of marine refuse. Living Lamma expressed that — (a) refuse found at beaches came from the sea, with some of them such as the yellow plastic bags of Marine Department ("MD") for collection of refuse being left by government contractors; and (b) the Administration should step up education and publicity to encourage the public producing less refuse and forming good habits in disposing refuse instead of just leaving them behind. Living Islands Movement echoed that a majority of marine waste originated from ships. It requested the Administration to adopt a holistic approach to tackle the matter instead of allocating responsibility for handling marine refuse at different parts of the shoreline to different departments. WWF expressed that — (a) the Administration should explore and explain why the number of prosecutions on marine littering offences dropped in recent years along with the increase of the amount of marine refuse, and step up its enforcement actions against marine

		littering, e.g. in Aberdeen Typhoon Shelter;	
		(b) the Administration should step up publicity and education in order to induce positive change of people's attitude towards keeping the sea clean, and work with community groups to enhance the effectiveness of publicity;	
		(c) MD (assisted by the Marine Police and the Agriculture, Fisheries and Conservation Department) should inspect marine littering black spots, in particular after adverse weather to clean up marine refuse piled up there instead of just acting on complaints; and	
		(d) the Administration should review and address the matter of seabed refuse.	
		MD responded that –	
		(a) it acknowledged the recent discovery of three MD's plastics bags among the marine refuse. Having checked the waste in the bags, it suspected that they might come from shipyards. It would launch more publicity among shipyards against marine littering;	
		(b) it was increasingly difficult to take prosecutions against marine dumping/littering as the complainants sometimes did not provide the licence number and/or the name of the ship concerned. It would disseminate information to educate the public on ways to identify the ships concerned;	
		(c) the drop in the number of prosecutions against marine littering was probably due to the decrease of marine littering of cigarette butts after the implementation of smoking ban in Hong Kong;	
		(d) it would carry out continuous publicity and education activities and law enforcement operations to raise public's awareness of keeping the sea clean, particularly at the black spots such as Aberdeen Typhoon Shelter in relation to which MD had taken a number of summon actions in 2014; and	
		(e) it would step up patrolling by road or sea transport and cleaning up the marine refuse (i) at sea shores immediately following a typhoon/adverse bad

004738 – 005351	Chairman Dr Helena WONG Administration Mr Frankie YICK	Briefing by the Administration on the application of section 4D of the Summary Offences Ordinance (Cap. 228) ("SOO").	
	Mr Albert CHAN	Members considered that there might be a loophole and urged the Administration to review the legislation to plug the loophole. The Transport and Housing Bureau undertook to refer the matter for relevant bureau's follow-up.	
005352 – 005931	Chairman Mr Albert CHAN	Mr CHAN suggested MD to make use of advanced surveillance cameras at black spots of marine dumping/littering to collect evidences of marine littering to deter such illegal activities. He also urged MD to modernize and improve its management on the marine affairs of Hong Kong (which included the management of the officers who were responsible to keep the Hong Kong waters clean) with a view to improving the overall marine services provided by MD.	
005932 – 010641	Chairman Administration	The Administration informed members that collection of marine refuse was undertaken by four government departments: gazetted beaches by Leisure and Cultural Services Department, marine parks and marine reserve by Agriculture, Fisheries and Conservation Department, unallocated coastal area by Food and Environmental Hygiene Department, and coastal waters/open waters/typhoon shelters by MD. It also briefly introduced the report of the study on the sources and fates of marine refuse ("the Study Report") issued by Inter-departmental Working Group on Clean Shorelines. The Chairman invited members to refer to the Study Report (LC Paper No. CB(4)1043/14-15(01)) which would be discussed at the meeting of the Panel on Environmental Affairs ("EA Panel") to be held on 22 June 2015. She hoped that the relevant government departments would work closely with the green and community groups in respect of collection of marine refuse.	
010642 – 010834	Chairman Mr Frankie YICK	Mr YICK urged the Environmental Protection Department to collaborate with the departments concerned and provide concrete solutions to tackle the problems identified in the Study Report at the said EA Panel meeting.

010835 – 011533	Chairman Mr Albert CHAN Administration	Mr CHAN expressed grave concern that refuse accumulation was repeatedly found at beaches which were usually cleaned up by volunteers. He strongly requested the departments concerned to step up their refuse cleaning services effectively and efficiently.			
011534 – 011411	Chairman Administration	The Chairman hoped that the Administration could devise a better complaint mechanism or communication channel to enhance law enforcement. MD advised that communication channels had been established with some green/community groups. In fact, MD had highly relied on the complaints/reports made by the public in dealing with cases of refuse accumulation which could be resolved in about two hours. On the other hand, the reports from green groups provided important information which helped the authority to formulate strategies in tackling the matter.
