
Limited Liability Partnerships (Top-up Insurance) Rules (L.N. 103 of 2015) (the Top-up Insurance Rules)

Re: Limited Liability Partnerships (Top-up Insurance) Rules (L.N. 103 of 2015) (the Top-up Insurance Rules)

I am scrutinizing the legal and drafting aspects of the Top-up Insurance Rules.

It is noted that rule 3 of the Top-up Insurance Rules has made references to certain provisions of the Insurance Companies Ordinance (Cap. 41). At a recent meeting of the Bills Committee formed to scrutinize the Insurance Companies (Amendment) Bill 2014, the Administration has proposed a number of amendments to rule 3 of the Top-up Insurance Rules (please see Annex B to LC Paper No. CB(1)946/14-15(02) which is available at the Legislative Council's website at http://www.legco.gov.hk/yr13-14/english/bc/bc06/ agenda/bc0620150605.htm as at the date of this letter). Please confirm whether the proposed amendments are acceptable.
