Legislative Council Panel on Education Public Policy Research Funding Scheme

Purpose

The Legislative Council Panel on Education wrote to the Head, Central Policy Unit (CPU) on 2 December 2014 to invite CPU to provide an update on the Public Policy Research Funding Scheme (PPRFS). This paper reports on the present position of the PPRFS.

Background

- 2. CPU briefed the Panel on Education on PPRFS on 21 February 2013 and 2 December 2013.
- 3. Since the introduction of the PPRFS in 2005, the Government has allocated \$20 million annually for promoting public policy research. From 2013-14 onwards, the CPU is administering the day-to-day operation of the PPRFS. The Scheme has been open for application since 16 July 2013. Details of the Scheme have been posted on CPU's web site (www.cpu.gov.hk). To increase the Scheme's flexibility and to cater for potential applicants' needs, applications are accepted throughout the year. Applications are processed once received. Vetting normally takes about three to four months. These arrangements allow the launch and completion of research in a more flexible and timely manner.
- 4. To encourage and support more academics and researchers to conduct public policy research, the Scheme is open to academics who are teaching undergraduate programmes or above; visiting scholars/adjunct professors/ honorary professors/emeritus professors and research officers who are eligible to teach undergraduate programmes or above at local degree-awarding institutions; as well as public policy researchers at local non-profit-making think tanks. This would further foster a culture of public policy research in Hong Kong.
- 5. To better address the current policy research needs of the community and the Government, CPU has formulated 21 indicative research areas for reference by tertiary institutions and think tanks. Applicants can also propose their own research areas for consideration by the Assessment Panel and CPU. Whenever a research need is identified, CPU would invite applications on special research topics.
- 6. To ensure academic freedom and quality of research, an Assessment Panel comprising 16 local experienced academics is responsible for the assessment of applications. The panel and reviewers, who are academics and experts outside the panel

assess the applications according to the assessment criteria and details already announced. A declaration of interests system is in place to ensure that assessments are fair and just.

7. To enhance the transparency of the Scheme, all research reports will be uploaded onto CPU's web site. CPU will organise seminars and workshops to encourage academics, researchers, experts, practitioners, officials and other stakeholders to exchange views on on-going or completed research.

Present Position

- 8. As of mid-November 2014, 116 applications were received. The total funding sought was about \$70 million. On the advice of the Assessment Panel, a total of 33 projects with a total funding of about \$15 million were approved, while 50 were declined. Other **applications** are being processed.
- 9. The funded projects cover a wide spectrum of policy areas, including land and housing, ageing and retirement protection, population policies, environmental protection, ethnic minorities, economic development, governance and administration, regional cooperation and development, poverty and inequality, ageing population, the impact of new media on politics and governance, and labour and employment.
