Proposed Revision of Fees and Charges under the Agriculture, Fisheries and Conservation Department

PURPOSE

This paper seeks Members' views on the proposal to revise 140 statutory fee items for services provided by the Agriculture, Fisheries and Conservation Department (AFCD).

BACKGROUND

2. In line with the "user pays" principle, it is Government's policy that fees and charges of Government services should in general be set at levels sufficient to recover the full cost of providing the services. In the 2013-14 Budget Speech, the Financial Secretary stressed that the Government needed to ensure a stable income by preserving tax revenue and adhering to the "user pays" principle in order to uphold fiscal sustainability and prudent management of public finances. To prevent cost recovery items from being turned into heavily subsidized items, the Government would review the fees and charges. The Government would first deal with fees that have not been revised for years and do not directly affect people's livelihood, as well as items which have low cost recovery rates. The Government had also undertaken that there would not be substantial revisions at one go to avoid affecting people's livelihood.

3. AFCD has reviewed a total of 146 statutory fee items. These fee items are prescribed in the following legislation:

- (i) Fisheries Protection Ordinance (Cap. 171);

111 items were last revised between 1996 and 2001, 29 were first introduced

between 1994 and 2002 and the other six were first introduced in 2012.

Among the 146 statutory fee items described in paragraph 3 above,

5. Major stakeholders include livestock/crop/dairy farmers, fishermen, animal owners, plant/animal exporters/importers, plant breeders, veterinary surgeons/clinics, persons/companies running boarding establishments etc.

PROPOSAL

6. AFCD has conducted a costing review on the 146 fee items and proposed revisions to 140 of them. Of the 140 fee items, the existing cost recovery rates (CRR) range from around 8.4% to 245.2%.

7. In order to achieve full cost recovery gradually and avoid a steep fee increase, we have adopted the following guidelines for the fee revision in our $proposal^{1}$ –

- (a) for items with an existing CRR of less than 40%, adopt an increase of about 20%;
- (b) for items with an existing CRR of 40% to 70%, adopt an increase of about 15%; and
- (c) for items with an existing CRR of over 70%, adopt an increase of about 10% or less.

8. For the statutory fee items, we propose to adjust 140 of them as set out at <u>Annex</u>. Of them, 129 items will see increases ranging from around 6% to 20%, and one item will increase by 429% (see explanation in paragraph 9 below). On the other hand, 10 fee items will see decreases ranging from around 5% to 60%. The remaining six items are to be maintained at their existing fee levels because their CRR are close to full cost recovery level. With the proposed revised fee levels for the 140 statutory fee items, their CRR will be revised to a range of around 10% to 100.6%.

9. For the fee item prescribed in the Veterinary Surgeons Registration (Fees) Regulation (Cap. 529A) (i.e. the veterinary surgeons registration fee), we propose to increase the fee level by 429% to \$4,100 to achieve full-cost recovery

at one go. The current fee level is \$775, which had only been increased once in 2001 from the fee level of \$725 set in 1997 when the Veterinary Surgeons Registration Ordinance (Cap. 529) was enacted. It is a one-time fee payable by the veterinary surgeons upon registration² and the registration status is essentially life-time unless the veterinary surgeon seeks a re-registration after his/her name has been removed from the register. If we follow the guideline as set out in paragraph 7 above and propose an annual increase of 20%, it would take over nine years to achieve full-cost recovery, assuming that the cost stays constant at the current level. Given that it is a one-off fee and the proposed fee level should still be affordable for a professional like veterinary surgeon, we consider it appropriate to increase the fee level to achieve full-cost recovery in this exercise.

10. The cost of the above fee items will be reviewed regularly and we will submit fee revision proposal as and when necessary, having regard to the "user pays" principle.

EFFICIENCY IMPROVEMENT MEASURES

11. AFCD will continue to enhance efficiency and streamline procedures so as to contain the costs of providing such services to the public.

FINANCIAL IMPLICATION

12. If the fee revision proposal as set out in <u>Annex</u> is implemented, the estimated net increase in revenue is about \$1.5 million per annum.

PUBLIC CONSULTATION

13. Relevant stakeholders (including animal/plant traders, animal transport agents, dairy licensee, livestock keeping licensees, marine fish culture licensees, registered veterinary surgeons, fishing vessel owners, research fishing permit holders, fishermen groups, plant varieties rights applicants/agents, farmers,

agricultural groups, fish farm owners, riding schools, etc.), have been informed of the fee revision proposal through letters or by notice on AFCD's website.

14. AFCD has issued letters to about 3 500 stakeholders and has so far received feedback from six parties. One person requested the Government to postpone the fee increase of boarding establishment licence under Cap. 139I, while four fishermen groups objected to the fee increase in respect of marine fish culture licence/permit, registration of local fishing vessels and/or research fishing permit pertaining to Cap. 353A and/or Cap. 171. There was a comment that the dog licence fee under Cap. 421A should be subsidised by public fund. We noted the comments received and understood that some members of the general public would not welcome fee increases. It is nevertheless noteworthy that a majority of the fee items were last revised in or before 2002. The proposed increase level is relatively mild³. We consider that the revised fees should be affordable.

NEXT STEPS

15. To give effect to the revision of the 140 statutory fee items, amendments to the relevant subsidiary legislation are required. The Government plans to table the relevant legislative amendments before the Legislative Council within the 2014/15 legislative session.

ADVICE SOUGHT

16. Members are invited to comment on the fee revision proposals in this paper.
