Regulation of Private Healthcare Facilities Consultation Document

COUNCIL MEMBERS 理事 Dr FOO Tai Chuen 傅大全醫生 When general anaesthesia (GA) and deep sedation such as monitored anaesthetic care (MAC) and intravenous sedation (IV sedation) are applied to dental and medical procedures, some possible side effects, risks and complications may be associated with. To safeguard the health of the public, regulations governing the application of GA, MAC and IV sedation in dentistry should be reinforced to eliminate unsupervised procedures in Hong Kong. We are of the view that the above-mentioned modes of anaesthesia or sedation should only be conducted within accredited premises equipped with certain standard of facilities such as resuscitation equipment.
