#### LEGISLATIVE COUNCIL BRIEF

#### PUBLIC HEALTH AND MUNICIPAL SERVICES ORDINANCE SETTING ASIDE PLACES FOR USE AS PUBLIC PLEASURE GROUNDS

#### INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance, Cap.132 ("the Ordinance"), manages the public pleasure grounds listed in the Fourth Schedule to the Ordinance. Under Section 106 of the Ordinance, the Authority may, from time to time, by order set aside places for use as public pleasure grounds, and may by order amend the Fourth Schedule.

2. We propose to introduce amendments through the Public Health and Municipal Services Ordinance (Public Pleasure Grounds) (Amendment of Fourth Schedule) (No.2) Order 2014 (the Amendment Order) to set aside the places specified in Schedule 1 of the Amendment Order for use as public pleasure grounds, to cease to set aside the places specified in Schedule 2 of the Amendment Order for use as public pleasure grounds, and to rename the public pleasure ground specified in the Schedule 3 of the Amendment Order. The Amendment Order is at Annex to this Brief.

#### **JUSTIFICATIONS**

3. The proposal to set aside 17 venues as public pleasure grounds will enable the Authority to enforce the Pleasure Grounds Regulation in those venues. We also propose to delete four venues from the Fourth Schedule as they cease to be used as public pleasure grounds and to rename the Chinese name of one venue.

# PLACES TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

4. The following 17 venues will be designated as public pleasure

#### grounds and be included in the Fourth Schedule —

- (i) Ten newly completed and existing venues that are or will open for public use by the Leisure and Cultural Services Department (LCSD):
  - (a) Chung Yee Street Garden
  - (b) Fuk Man Garden
  - (c) Hang Fai Street Park
  - (d) Hoi Fai Road Promenade
  - (e) Kwun Tong Recreation Ground
  - (f) On Muk Street Garden
  - (g) San Pak She Street Sitting-out Area No. 6, Cheung Chau
  - (h) San Pak She Street Sitting-out Area No. 7, Cheung Chau
  - (i) Tin Yip Road Sitting-out Area
  - (j) Tseung Kwan O Waterfront Park
- (ii) Seven venues that are taken over from the Home Affairs Department (HAD) for management by LCSD:
  - (a) Lam Tei Pet Garden
  - (b) Praya Street Sitting-out Area
  - (c) Quarry Bay Salt Water Service Reservoir Sitting-out Area
  - (d) Tai Ha Street Garden
  - (e) Tai Hing North Sitting-out Area
  - (f) Tai Kwai Wan Garden
  - (g) Tung Koon San Tsuen Sitting-out Area

# PLACES CEASING TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

5. Four venues, namely Aberdeen Waterfront Garden, Hong Ning Road Children's Playground, Yan Oi Court Garden and Hip Wo Street/Mut Wah Street Sitting-out Area will be deleted from the Fourth Schedule as they have ceased to be public pleasure grounds. The Aberdeen Waterfront Garden and Aberdeen Promenade have been collectively renamed as Aberdeen Promenade while the Hong Ning Road Children's Playground, Yan Oi Court Garden and Hip Wo Street/Mut

Wah Street Sitting-out Area have been handed over to Lands Department for development of Kwun Tong Town Centre Project by the Urban Renewal Authority.

#### RENAMING OF PUBLIC PLEASURE GROUND

6. The Chinese name of Aberdeen Promenade (香港仔海濱花園) will be renamed as "香港仔海濱公園" after its refurbishment together with Aberdeen Waterfront Garden. The renaming is supported by the Southern District Council.

#### AMENDMENT OF FOURTH SCHEDULE

7. The Amendment Order at <u>Annex</u> amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to give effect to the changes set out in paragraphs 4, 5 and 6 above.

#### LEGISLATIVE TIMETABLE
