### Legislation Publication (Revision) Order 2014

#### INTRODUCTION

The Legislation Publication Ordinance (Cap. 614) (“LPO”) was enacted in June 2011. In exercise of the power conferred by section 17 of the LPO, the Secretary for Justice has made the Legislation Publication (Revision) Order 2014 (the “**Order**”) at the **Annex**. The purpose of the Order is to make amendments to various Ordinances to ensure that the relevant provisions are accurate, up-to-date and accord with current legislative drafting practices.

#### JUSTIFICATIONS

2. The revisions to Ordinances help enhance the readability of our legislation, secure uniformity in expression across the statute book and standardize the nomenclature used within a legislative instrument. The revision regime is an efficient mechanism to improve and modernize the statute book in accordance with the prevailing drafting conventions.

#### THE ORDER

3. The Order makes alterations to different Ordinances for the purpose of securing uniformity in expression. For example, the reference to “《海關條例》” in various enactments is substituted by “《香

港海關條例》”to accord with the Chinese short title of the Customs and Excise Service Ordinance (Cap. 342). The reference to “全職學生” in the Schedule to the Public Health and Municipal Services (Fees and Charges) (Museums) Regulation (Cap. 132 sub. leg. CK) is replaced by “全日制學生” for internal consistency.

4. Amendments are made to Schedule 2 to the Business Registration Ordinance (Cap. 310) to replace the description of the commencement date of the Business Registration (Amendment) Ordinance 2010 (13 of 2010) with an actual calendar date to save time of legislation users in ascertaining the date.

5. In addition, amendments are made to the Bankruptcy Rules (Cap. 6 sub. leg. A) (**Cap. 6A**), the Prison Rules (Cap. 234 sub. leg. A) (Cap. 234A) (**Cap. 234A**), the Frontier Closed Area (Permission to Enter) Notice (Cap. 245 sub. leg. H), the Marine Fish (Marketing and Exportation) Regulations (Cap. 291 sub. leg. A) and the Prison (Amendment) Rules (L.N. 60 of 2012) to change the way of referring to a provision. “Paragraph” in these chapters are replaced by “subrule” or “subregulation” as appropriate.

6. The Order also arranges the provisions of Cap. 6A, Cap. 234A, the Patents (General) Rules (Cap. 514 sub. leg. C) and the Trade Marks Rules (Cap. 559 sub. leg. A) into Divisions and Subdivisions according to their existing structure to facilitate readers’ navigation through the legislation.

## **IMPLICATIONS**

8. The Order is in conformity with the Basic Law, including the provisions concerning human rights. It has no economic, environmental, sustainability, productivity, financial, civil service or family implications. The Order does not affect the binding effect of the Ordinances and subsidiary legislation being amended.

## **CONSULTATION**

9. We briefed the Legislative Council Panel on Administration of Justice and Legal Services on 26 March 2012 and informed the Panel that revision Orders will be introduced on a regular basis.<sup>1</sup> All bureaux which have policy responsibilities over the affected legislation have been consulted.

## **PUBLICITY**

**Explanatory Note**

The purpose of this Order is to make amendments to various Ordinances to ensure that the relevant provisions are accurate, up-to-date and accord with the current legislative drafting practices.

2. The Order is divided into 5 Parts. Part 1 provides for commencement.
3. Part 2 makes alterations to different Ordinances for the purpose of securing uniformity in expression.
4. Part 3 amends item 2(a) of the Table in Schedule 2 to the Business Registration Ordinance (Cap. 310) to replace a reference to a date in the form of a description by the actual calendar date.
5. Part 4 amends the following to change the way of referring to a provision—
  - (a) the Bankruptcy Rules (Cap. 6 sub. leg. A);
  - (b) the Prison Rules (Cap. 234 sub. leg. A);
  - (c) the Frontier Closed Area (Permission to Enter) Notice (Cap. 245 sub. leg. H);
  - (d) the Marine Fish (Marketing and Exportation) Regulations (Cap. 291 sub. leg. A); and
  - (e) the Prison (Amendment) Rules 2012 (L.N. 60 of 2012).
6. Part 5 amends the following Rules to organize the provisions of the Rules into, and assign numbers and headings to, groups of provisions—
  - (a) the Bankruptcy Rules (Cap. 6 sub. leg. A);
  - (b) the Prison Rules (Cap. 234 sub. leg. A);
  - (c) the Patents (General) Rules (Cap. 514 sub. leg. C); and
  - (d) the Trade Marks Rules (Cap. 559 sub. leg. A).
