茲收到 貴局於 2016 年 5 月 19 日之信件 (檔案編號: SBCR 1/2361/14) 關於"註冊消防工程師計劃"。本人代表香港工程師學會消防工程界別,感謝保安局及消防處安排介紹了將來註冊消防工程師的訂立法例標準及要求,及此註冊消防工程師條例的審議過程及安排。

在此本會再次明確全力支持此條例草案盡快通過,好為業界及社會帶來正面的信息,也可令消防處撥出更多資源服務市民。

本會對草案條例中建議的三種註冊消防工程師學歷及相關的工作經驗、時間等,大致上認同及支持。但本會亦重申將來的註冊消防工程師,一定要有認可消防工程科學位或已經修讀適當有關的消防工程銜接課程,及從事相關的消防工程工作,因為此註冊消防工師將來的工作,將會涉及人命及財產的安全,絕對不可以輕率。

因此本會認為,將來條例通過後,政府應該小心處理其他擁有不太相關學歷及 沒有接受過工程科基本訓練的學位的申請者,要嚴格依照草案條例內的建議及 要求,執行審批註冊消防工程師的申請。

至於建議中提及的"先審議後訂立"的安排,為著要盡快平息各方的爭議及通過此條例草案,本會亦表示支持。

Comments on the Proposed Registered Fire Engineer (RFE) Scheme In reference to the meeting with the Security Bureau and Fire Services Department on 17 May 2016 and subsequent to the letter dated 19 May 2016 from the Security Bureau

- (1) For the proposed entry routes, we have the following comments:
 - (a) General comments on Routes (i), (ii) and (iii)
 - It is necessary to well define what types of working experience are qualified under each category of RFE, for instance, consultancy services for license application, smoke control design.
 - (b) Additional comments on Route (ii)
 - Given the academic background or relevant top-up course requirements, it
 is suggested reducing the required number of years of relevant working
 experience from 6 years to 3 years in this pilot scheme.
 - (c) Additional comments on Route (iii)
 - Minimum academic qualification similar to Route (ii) is suggested, which aims to maintain an adequate level of knowledge base.
 - Similar to Route (ii), it is suggested reducing the required number of years of relevant working experience from 15 years to 12 years in this pilot scheme.
 - Experienced practitioners will normally provide strategic views and concepts on fire safety issues. Their competency should not be gauged on the same assessment criteria as for professionals at operational level. With a view to engaging these truly experienced practitioners, it is suggested to waive the top-up course requirements in this pilot scheme.
- (2) The Registration Committee for assessing the competency of applicants should be well represented by different stakeholders in the industry, which should include The Hong Kong Institute of Surveyors, Hong Kong Institution of Engineers and other bodies as appropriate.
- (3) We are neutral to the title "Registered Fire Engineer" as it only reflects the position or job title of a wide spectrum of professionals who undertake fire safety related assignments.
- (4) Positive vetting of the amendment bill is supported.
