> 立法會《2016年醫生註冊(修訂)條例草案》委員會主席 方剛議員台鑒:

《2016年醫生註冊(修訂)條例草案》修訂

就《2016 年醫生註冊(修訂)條例草案》(下稱《條例草案》),政府建議 把香港醫務委員會的業外委員數目由 4 名增至 8 名。醫學界均贊成增加業外 委員,但要求政府相對增加由選舉產生的業內委員人數。

因此,本人擬於全體委員會審議階段,提出兩項修正案,同時建議修訂 《條例草案》第4條,關於醫務委員會的設立及組成,其中一項可簡稱為「4+4」 修正案,另一項為「6+6」修正案(詳見附件),供議員考慮及選擇。

「4+4」修正案旨在增加4名業外委員及4名由選舉產生的業內委員,使業 外委員總數增至8名,業內委員總數增至11名醫生。「6+6」修正案則旨在增 加6名業外委員及6名由選舉產生的業內委員,使業外委員總數增至10名, 業內委員總數增至 13 名醫生。在這兩個方案下,醫委會內的選舉和委任席位 都能維持 1:1 的比例。

上述兩項修訂均能增加醫委會的公信力及維護醫學界的「專業自主」。本 人期盼主席及各位議員能支持有關的修正案。
