## Bills Committee on Electoral Legislation (Miscellaneous Amendments) (No. 2) Bill 2015

## Follow up on issues raised at the Meeting on 6 January 2016

At the meeting of the Bills Committee on Electoral Legislation (Miscellaneous Amendments) (No. 2) Bill 2015 on 6 January 2016, some Members requested the Government to provide supplementary information on the differences and similarities of the delineation of electorates between Election Committee ("EC") subsectors and Functional Constituencies ("FCs") of the Legislative Council ("LegCo"). This paper provides the relevant information for reference.

2. According to Annex I to the Basic Law and the Chief Executive Election Ordinance (Cap. 569), the EC is composed of 38 subsectors in four sectors. The four sectors are:

First sector:	Industrial, commercial and financial sectors;	
Second sector:	The professions;	
Third sector:	Labour, social services, religious and other sectors; and	
Fourth sector:	Members of the LegCo, representatives of members of the District Councils, representatives of the Heung Yee Kuk, Hong Kong deputies to the National People's Congress, and representatives of the Hong Kong members of the National Committee of the Chinese People's Political	

3. The differences and similarities of the delineation of electorate between the 38 subsectors and LegCo FCs are listed in the table below –
