#### I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

#### Committee stage amendments ("CSAs") proposed by members

2. <u>Members</u> considered Mr SIN Chung-kai's proposed CSAs to the proposed new section 32NA(1)(b) and the Administration's response [LC Paper Nos. CB(2)1368/15-16(01)] and CB(2)1436/15-16(01)]. <u>Members</u> also noted that Mr LEUNG Yiu-chung had indicated his intention to propose amendments to the amount of the further sum, which was currently proposed in the Employment (Amendment) Bill 2016 ("the Bill") to be set at three times the employee's average monthly wages, subject to a maximum of \$50,000. <u>Members</u> agreed that the Chairman of the Bills Committee would not move any amendments to the Bill on behalf of the Bills Committee.

#### Follow-up actions required of the Administration

3. The Administration undertook to convey to the Labour Advisory Board ("LAB") the views and concerns raised by members at the meetings of the Bills Committee and provide a written response on its proposed way forward after consulting LAB. Members agreed that the Administration's response, once available, be issued for their reference by circulation.

4. <u>The Chairman</u> concluded that, pending the Administration's provision of written response to the above issues, the Bills Committee had completed scrutiny of the Bill. <u>Members</u> agreed that there would be no need to hold the next meeting scheduled for 17 May 2016 to discuss the above response to be provided by the Administration unless warranted.

(*Post meeting note*: With the concurrence of the Chairman, the next meeting scheduled for 17 May 2016 was cancelled pending the Administration's response to the issues raised at the meeting.)

003722 - 003822	Chairman	The Chairman cast doubt about Mr SIN Chung-kai's proposed CSAs, which sought to remove the proposed cap on the amount of the further sum, as the proposal departed from the usual practice of stipulating a cap on remedies in the legislation.	
003823 - 004117	Chairman Mr POON Siu-ping	Mr POON Siu-ping shared Mr LEUNG Yiu-chung's view that the amount of the further sum should be adjusted upward to reflect the wage increase over the years and better protect the low-paid employees.  The Administration considered that the proposed further sum should be subject to a ceiling, given that it was an amount in addition to the terminal payments and compensation which might be up to \$150,000 payable to the employee concerned. The Administration reiterated that the amount of the further sum proposed in the Bill was a hard-earned consensus reached by the Labour Advisory Board ("LAB") following rounds of discussion.	
004118 - 004314	Chairman Admin	In response to the Chairman's enquiry, the Administration advised that the next meeting of LAB would be held shortly and all the views expressed by members on the Bill, including those regarding the proposed amount of the further sum, would be conveyed to LAB for consideration. Subject to the further deliberation of LAB, the Administration would consider the way forward on the Bill.	
004315 - 004550	Chairman Mr YIU Si-wing Admin	Mr YIU Si-wing reiterated his view that a cap should be imposed on the amount of the further sum having regard to the affordability of employers, particularly those of small and medium-sized enterprises ("SMEs"). While it was considered reasonable to make adjustment in the amount of the further sum in the light of the wage increase over the years, any consensus reached by LAB should be respected.  The Administration took note of Mr YIU's concern and would relay it to LAB.

004551 - 004738	Chairman Mr SIN Chung-kai	Mr SIN Chung-kai considered that his proposed CSAs would not bring significant impact on SMEs given that making reinstatement or re-engagement orders were not common. On the other hand, his proposed CSAs would enhance the deterrence effect against non-compliance with the reinstatement or re-engagement order by the employer in an unreasonable and unlawful dismissal case.	. 1
004739 - 004959	Chairman Mr Andrew LEUNG Admin	Mr Andrew LEUNG was concerned that the Bill could not be passed within the current legislative session if LAB was unable to reach a consensus on any revised proposals right away. He asked whether the Administration would consider withdrawing the Bill if it did not agree to the CSAs proposed by members.  The Administration responded that it would relay members' views and concerns regarding the Bill to LAB for consideration. The time required for LAB to deliberate the issues would depend on the relevant circumstances.	
005000 - 005225	Chairman Mr LEUNG Yiu-chung	Given that the court or LT had already taken into account various factors when making an order for reinstatement or re-engagement, Mr LEUNG Yiu-chung considered that an employer who failed to comply with such an order should be liable to higher penalties so as to enhance the deterrence effect and provide greater employment protection for grassroots employees. In his view, the amount of the further sum should be increased to at least six times the employee's monthly wages up to a maximum of \$100,000.	
005226 - 005419	Chairman Mr CHUNG Kwok-pan	Mr CHUNG Kwok-pan reiterated his concern about the practicability of compliance with the reinstatement or re-engagement order by the employer having regard to the strained relations between the employer and employee concerned. Given that it was not easy to reach consensus among members of LAB on the matter and the proposed further sum would inevitably impose additional financial burden on SMEs, he considered the proposed amount of the further sum in the Bill an appropriate starting point.
