#### **Action**

#### I. Meeting with the Administration

[File Ref.: FHCR1/F/3261/92, LC Paper Nos. LS44/15-16, CB(2)1118/15-16(02) to (04), CB(2)1131/15-16(01), CB(2)1317/15-16(01), CB(2)1349/15-16(02), CB(2)1363/15-16(01), CB(2)1380/15-16(01) to (03), CB(2)1408/15-16(01), CB(2)1417/15-16(01) and CB(3)422/15-16]

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

#### Admin 2. <u>The Bills Committee</u> requested the Administration to:

- (a) in respect of the proposed three additional lay members of the Medical Council of Hong Kong ("the Medical Council") who would be elected by the patient-related groups for appointment by the Chief Executive,
  - (i) in addition to the brief information as set out in Annex A to LC Paper No. CB(2)1380/15-16(03), provide further details of the factors to be taken into consideration by the Secretary for Food and Health in determining whether an organization or body would be eligible for electing the three persons to fill these seats;
  - (ii) provide the proposed guidelines on the detailed election arrangement being formulated by the Administration in consultation with the patient-related groups; and
  - (iii) provide a list of the patient-related groups being consulted on the Administration's proposal in this regard and a summary of their views and concerns on the proposal;
- (b) in respect of a member's view that the response given by the Administration in relation to the nine bottlenecks of the existing complaints investigation and disciplinary inquiry mechanism of the Medical Council as raised at the meeting on 25 April 2016 (LC Paper No. CB(2)1408/15-16(01)) was far from comprehensive, provide further details on the following:
  - (i) information on the breakdown, by the nine bottlenecks, of the average time required by the Medical Council for the handling of complaint cases at different stages; and
  - (ii) the respective administrative measures for shortening the

time required of the Medical Council for handling complaints as referred to in item (i) above, with a breakdown by those that could only be implemented upon the enactment of the Bill and those that could still be implemented even if the Bill was not passed;

- (c) advise the progress of the Medical Council in formulating the guidelines in relation to the declaration by a member of the Preliminary Investigation Committee of an interest in a case and provide the guidelines for reference by members of the Bills Committee when available. It was stated in the judgment in *Law Yiu wai*, *Ray v. The Medical Council of Hong Kong and Others* (HCAL 46 of 2015) handed down by the Court of First Instance on 12 October 2015 that the Medical Council lacked appropriate guidelines in this regard; and
- (d) advise whether it would introduce mediation as one of the mechanisms for the Medical Council to handle complaints against registered medical practitioners, and provide information about the practices of overseas jurisdictions in this regard.

001729 - 002403	Chairman Mr Albert HO Admin	Mr Albert HO's view that there was not much controversy about the legislative proposal of extending the maximum term of limited registration and renewal of such registration.  In response to Mr Albert HO's enquiry as to how the provision of honorarium as a token of appreciation to experts who assisted in the investigation work at the Preliminary Investigation Committee ("PIC") stage as proposed by the Administration in		
		paragraph 6 of LC Paper No. CB(2)1408/15-16(01) could help shorten the time required for obtaining an independent expert opinion, the Administration's advice that the proposal was raised by the Medical Council. It was estimated that if the Bill was not passed, the average time for handling a complaint case could at best be shortened by two to four months through administrative measures. However, upon the passage of the Bill and after clearing the backlog of cases, it was estimated that the average time for handling a complaint case could be shortened from 58 months to about 30 months.		
		Mr Albert HO's view that it was of utmost importance that the election of the three additional lay persons representing the patients' interests for appointment by the Chief Executive ("CE") on the Medical Council, and the election of the two registered medical practitioners by the Hong Kong Academy of Medicine ("the Academy of Medicine") to sit on the Medical Council, were conducted without any interference from the Government. The latter was particularly important for ensuring that an equal ratio between appointed members and elected members in the Medical Council could be maintained.

		The Administration's advice that it was for the Medical Council Secretariat to decide on its additional manpower requirements in order to help the Medical Council to expedite the handling of complaint cases; and its assurance that apart from the additional provision of \$4 million, more resources would be provided upon passage of the Bill, depending on the additional number of PICs to be established by the Medical Council and the increase in the frequency of disciplinary inquiry hearings. At present, the annual remuneration for the Legal Adviser to the Medical Council was about \$3.1 million. 		Dr KWOK Ka-ki's suggestion that to preserve professional autonomy, one of the two registered medical practitioner member seats to be nominated respectively by the University of Hong Kong ("HKU"), The Chinese University of Hong Kong ("CUHK"), the Hospital Authority ("HA") and the Academy of Medicine for appointment by CE should be converted to four elected seats to be elected by registered medical practitioners with full registration and limited registration.	
		The Administration's advice that the registered medical practitioners nominated by the two universities and HA had to represent HKU, CUHK and HA to provide views to the Medical Council from the perspective of local medical training institutions and the major public healthcare services provider respectively.
