# Bills Committee on the Medical Registration (Amendment) Bill 2016 

Medical Council of Hong Kong<br>Ratio of Elected and Appointed Members and<br>Proposed Composition of the Four Additional Lay Members

## PURPOSE

This paper sets out -
(a) the Government's proposal that aims to address concerns over the ratio of elected and appointed members in the Medical Council of Hong Kong ("MCHK"); and
(b) the proposed composition of the four additional lay members and the idea that they should be appointed based on nomination.

## Ratio of Elected and Appointed Members in MCHK

2. In response to consultation with relevant stakeholders including doctors' associations, patient groups and Legislative Council Members to discuss possible options ${ }^{1}$ in achieving an equal ratio of elected and appointed members in MCHK, the Government will look into the possibility of introducing committee stage amendment ("CSA") to increase the elected element in the composition of MCHK. We propose to convert the two existing appointed members nominated by the Hong Kong Academy of Medicine ("HKAM") to two members to be elected by the Council of $\mathrm{HKAM}^{2}$, following similar arrangement for the seven elected members of the Hong Kong Medical Association as stipulated in

[^0]section (3)(i) of the Medical Registration Ordinance (Cap. 161) ${ }^{3}$. The current and proposed composition of MCHK after taking into account our latest proposal is at Annex.

## Proposed Composition of the Four Additional Lay Members

3. The Government further proposes to introduce CSA to make it clear in the Amendment Bill that the four additional lay members to be appointed by the Chief Executive ("CE") should come from among sectors representing patients' interest and consumers' interests. Arrangements could be introduced for the relevant sectors to nominate their representatives for appointment by CE in a manner similar to the present nomination-based appointment of the ten doctors, two each nominated by the Director of Health, Hospital Authority, Chinese University of Hong Kong, University of Hong Kong and Hong Kong Academy of Medicine.

[^0]:    1 The Government does not accept the proposed corresponding increase of elected doctor members (i.e. " $4+4$ " or " $6+6$ " proposals) on the ground that there are already 24 doctor members in the current MCHK.

    2 The Council of HKAM consists of 26 members, consisting of six Officers (a President, two Vice-Presidents, Honorary Secretary, Honorary Treasurer, and Editor), 15 College Presidents, and five elected Council members.
