1. Introduction

- 1.1 The Legislative Council adopted at its meeting of 19 March 2014 the Policy on Access to the Legislature's Documents and Records ("the Policy") at Schedule 2 to the Rules of Procedure. The Council also approved the establishment of the Committee on Access to Legislature's Documents and Records ("the Committee") to carry out the functions as set out in the new Rule 74A of the Rules of Procedure, including determining whether a document or record of the Legislature or its committee should be made available for access earlier than the expiry of the closure period; setting guidelines for implementing the Policy; considering any objection against the denial of access to such a document or record by the Clerk to the Legislative Council; and considering any other matter relating to or arising from the Policy.
- 1.2 The Committee consists of the President, who shall be the chairman of the Committee, the chairman of the House Committee, who shall be the deputy chairman of the Committee, the deputy chairman of the House Committee and not more than 10 other members who shall be elected at a House Committee meeting in such manner as the House Committee may determine. The membership lists are in **Appendix I**.
- 1.3 This report covers the period from April 2014 to July 2016, during which five meetings were held to deliberate the following issues
 - (a) Exempted categories of the documents and records of the Legislature;
 - (b) Access to unclassified documents and records of the Legislature;
 - (c) Practice and procedure of the Committee; and
 - (d) Consideration of access requests for documents and records of the Legislature.

2. Exempted categories of the documents and records of the Legislature

- 2.1 The Legislative Council Secretariat conducted in 2013 two separate consultation exercises with Members and the public to seek views on the proposed list of exempted categories of documents and records of the Legislative Council Secretariat to which an access request might be refused. Members and public were in general supportive of the proposed list which was subsequently adopted by The Legislative Council Commission ("the Commission") in relation to access to its own documents and records.
- 2.2 At the meeting on 20 May 2014, the Committee has made reference to the list of exempted categories adopted by the Commission and adopted its own list of exempted categories. The Committee also agreed that the exempted categories would be applied in the conduct of review under the Policy and the consideration of any access request in respect of closed documents and records. The list of exempted categories adopted by the Committee has been uploaded onto the Website of the Legislative Council.

3. Access to unclassified documents and records of the Legislature

3.1 Under the Policy, the 50-year maximum closure period applies to documents and records of closed meetings of the Legislature which contain classified and unclassified documents and records not meant for public access at the time of their creation or receipt by the Legislature. They are mainly documents and records of the former In-house of Legislative Council, panels of Unofficial Members of the Executive and Legislative Councils, Office of the Members of the Executive and Legislative Councils and Office of the Members of the Legislative Council, Ad Hoc Groups, working groups, expert group and steering groups¹, bills committees and panels, as well as documents and records in relation to Members' meetings with District Boards, Provisional District Boards and District Councils. Although many of the above

committees met behind closed doors before 1993, they performed functions similar to those of the present committees which hold open meetings. The nature and contents of these older unclassified documents and records are also substantially the same as those of the present committees.

3.2 In view of the above, the Committee decided at its meeting on 20 May 2014 that the unclassified documents and records of the committees mentioned above which are kept by the Secretariat should be made available for access when they have been in existence for 20 years, subject to a review conducted by the Clerk to the Legislative Council.

4. Practice and procedure of the Committee

- 4.1 Rule 74A(11) of the Rules of Procedure provides that subject to the Rules of Procedure, the Committee may determine its own practice and procedure for the handling of access requests. In drawing up its own practice and procedure, the Committee has considered various principles, including transparency, efficiency and consistency regarding how it should consider an access request in order to ensure that the public's right to access information of the Legislature would not be unduly undermined. The Committee endorsed its practice and procedure at the meeting on 27 November 2014.
- 4.2 To streamline the procedure for handling access requests and to facilitate the work of Members, the Committee subsequently revised its practice and procedure by adding new provisions for the handling of access requests from Members. Under the new arrangement, a Member, subject to some conditions, will be allowed to access the confidential or closed documents or records of a committee if he is a former member of the committee and the requested documents or records are those that had been provided or issued to him in his capacity as member of that committee before the committee was dissolved or became defunct. Similar arrangement is also applied to access requests from government bureaux and departments. The revised practice and procedure, which was endorsed by the Committee in March 2016 has been uploaded onto the Website of the Legislative Council.

5. Consideration of access requests for documents and records of the Legislature

- 5.1 In handling an access request, the Secretariat follows the practice and procedure to conduct a review to determine whether such documents or records fall within any of the exempted categories. For confidential documents or records, the Committee's approval will be sought on whether the access should be granted or granted with conditions. The Committee's approval is also required for access to closed documents and records prior to the expiry of their closure period. Under the delegated authority, the Clerk to the Legislative Council may also approve access requests for closed documents or records the closure period of which has expired. To enhance transparency, the Committee has published the updated lists of approved and denied access requests onto the Legislative Council Website.
- 5.2 A total of 39 access requests, including seven requests with partial disclosure, were approved and one access request was denied during the period covered by this report. Details of these access requests are in **Appendix II**.

6. Acknowledgement

6.1 The Committee wishes to record their appreciation of Members of the Council for their support for the work of the Committee.
