## Schedule

### Amendments to Public Health (Animals and Birds) (Animal Traders) (Amendment) Regulation 2016

#### 1. Section 10 amended (regulations 5A to 5H added)

(1) Section 10—

**Renumber new regulation 5D as regulation 5D(1).**

(2) Section 10, new regulation 5D(1)—

**Repeal**

“The Director”

**Substitute**

“Subject to paragraph (2), the Director”.

(3) Section 10, after new regulation 5D(1)—

**Add**

“(2) The Director must not grant a licence unless the gross floor area of the premises is not less than 2 000 square feet.

(3) In this regulation—

***gross floor area*** (總樓面面積) means the floor area contained

within the external walls or fence of the premises measured at each floor level and if the premises are composed of more than one floor, including the floor area of each floor, together with the area of each balcony in the premises, which shall be calculated from the overall dimensions of the balcony (including the thickness of the sides thereof), and the thickness of the external walls or fence of the premises.”.
