Finance Committee Follow-up to meeting on 13 May 2016 FC(2016-17)18

I refer to your email of 16 May 2016 requesting the Government to provide a comparison between the actual and required provisions according to the current planning standards for sports facilities in Hong Kong. Our response is set out below.

Chapter 4 of the Hong Kong Planning Standards and Guidelines ("HKPSG") on "Recreation, Open Space and Greening" is on the planning standards for recreation and sports facilities. Apart from facilities provided by the Leisure and Cultural Services Department ("LCSD"), the HKPSG stipulated that facilities provided in both public and private housing developments should be suitably taken into account when considering the overall level of provision. Our current data is limited to sports facilities provided by the LCSD and hence we could not provide a comprehensive comparison between the supply and the standard stipulated in the HKPSG. With this limitation, a summary table showing the provision of major sports facilities by LCSD against the planning standard is shown in the **Annex**.

A Working Group on Sports Facilities ("WG") was established under the Sports Commission last year to review the provision of various types of sports facilities and to consider whether and how the current HKPSG should be updated. Taking into account the views of WG Members, the Home Affairs Bureau will commission a consultancy study on demand and supply of sports facilities in Hong Kong. One of the tasks of the consultant will be to collect information on sports facilities not managed by LCSD, including those in public estates, schools and tertiary institutions, private residential developments and private sports clubs; and to appraise their roles in the overall provision of sports facilities taking into consideration factors such as accessibility, quality of facilities and certainty of facility provision. completed, the study will provide a comprehensive picture on the provision of sports facilities and, through its recommendations on how HKPSG should be updated, help us to better serve the needs of today's community in planning for sports and recreation facilities. The WG aims to complete the review by the end of 2017.
