Action

I. Confirmation of the minutes of the 1st meeting held on 16 October 2015

(LC Paper No. CB(2)68/15-16)

The minutes were confirmed.

II. Matters arising

Report by the Chairman on his meeting with the Chief Secretary for Administration

2. <u>The Chairman</u> said that he had told the Chief Secretary for Administration ("CS") that he and Mr CHAN Kin-por, the Chairman of

the Finance Committee, attended a meeting of the pan-democratic Members on last Friday, 16 October 2015 ("the said meeting"). He had indicated at the said meeting that he would inform the pan-democratic Members of the special issues that had been discussed during his meeting with CS and would continue, as always, to relay views and concerns raised by Members at the House Committee ("HC") meetings to CS.

3. <u>Ms Cyd HO</u> said that while the Chairman was willing to undertake the role of a communication bridge between the pan-democratic Members and the Administration, she must reiterate that the arrangement of having a pan-democratic Member as the Deputy Chairman of HC to have direct communication with the Administration could not be replaced by other arrangements.

III. Legal Service Division report on subsidiary legislation gazetted on 16 October 2015

(LC Paper No. LS3/15-16)

4. At the invitation of the Chairman, <u>Legal Adviser</u> briefed Members on the Legal Service Division report on the two items of subsidiary legislation (i.e. L.N. 200 to L.N. 201) which were gazetted on 16 October 2015 and would be tabled in Council on 28 October 2015.

5. <u>The Chairman</u> said that normally no subcommittee would be formed to study in detail the order made for declaring geographical constituencies for the purpose of electing Members of the Legislative Council. Members would clearly have an interest in the matter.

6. While noting the Chairman's advice, <u>Ms Emily LAU</u> considered it necessary to form a subcommittee to study the Declaration of Geographical Constituencies (Legislative Council) Order 2015 (i.e. L.N. 200) in detail. <u>Members</u> agreed. Ms Emily LAU, Ms Cyd HO, Mr IP Kwok-him, Mr Alan LEONG and Mr SIN Chung-kai agreed to join the subcommittee.

7. <u>Members</u> did not raise any question on the remaining item of subsidiary legislation (i.e. L.N. 201).

8. <u>Members</u> noted that the deadline for amending these two items of subsidiary legislation would be the Council meeting of 25 November 2015, or that of 16 December 2015 if extended by a resolution of the Council.

IV. Further business for the Council meeting of 28 October 2015

9. <u>The Chairman</u> informed Members that the meeting would be suspended at about 8:00 pm on Wednesday, 28 October 2015. If necessary, the meeting would resume at 9:00 am on Thursday, 29 October 2015 and be adjourned after conclusion of all the business on the Agenda.

10. <u>The Chairman</u> said that the Report covered 21 items of subsidiary legislation, the period for amendment of which would expire at the Council meeting of 28 October 2015. No Member had indicated intention to speak on these items of subsidiary legislation.

11. <u>The Chairman</u> informed Members that Mr TANG Ka-piu had replaced his oral question.

12. <u>The Chairman</u> said that the Chairmen of the two subcommittees studying the above items of subsidiary legislation would move a proposed resolution respectively at the Council meeting to extend the scrutiny period of the above items of subsidiary legislation to the Council meeting of 18 November 2015.

V. Business for the Council meeting of 4 November 2015

15. <u>Members</u> noted that the Second Reading debates on the above two Bills would be resumed at the Council meeting of 4 November 2015.

16. <u>The Chairman</u> said that no notice had been received yet.

17. <u>Members</u> noted that debates on the above two Members' motions would be held at the meeting.

VI. Reports of Bills Committees and subcommittees

(a) Report of the Bills Committee on Inland Revenue (Amendment) (No. 3) Bill 2015 (LC Paper No. CB(1)32/15-16)

18. <u>Mr Kenneth LEUNG</u>, Chairman of the Bills Committee, briefed Members on the deliberations of the Bills Committee as detailed in its report. <u>Members</u> noted that the Bills Committee supported the Bill in principle, and both the Administration and the Bills Committee would not propose to move any Committee stage amendments ("CSAs") to the Bill. <u>Members</u> also noted that the Bills Committee supported the resumption of the Second Reading debate on the Bill at the Council meeting of 4 November 2015.

(b) Report of the Bills Committee on Securities and Futures (Amendment) Bill 2015

(LC Paper No. CB(1)34/15-16)

19. <u>Mr CHAN Kam-lam</u>, Chairman of the Bills Committee, briefed Members on the deliberations of the Bills Committee as detailed in its report. <u>Members</u> noted that the Bills Committee and the Administration would not propose to move any CSAs to the Bill. <u>Members</u> also noted that the Bills Committee supported the Administration's proposal to resume the Second Reading debate on the Bill at the Council meeting of 4 November 2015.

20. <u>The Chairman</u> reminded Members that the deadline for giving notice of CSAs, if any, proposed to be moved to the above two Bills would be Monday, 26 October 2015.

VII. Position on Bills Committees and subcommittees

(LC Paper No. CB(2)69/15-16)

21. <u>The Chairman</u> said that as at 22 October 2015, there were 13 Bills Committees, 15 subcommittees under HC and seven subcommittees on policy issues under Panels in action. Three subcommittees on policy issues were on the waiting list.

VIII. Priority allocation of a debate slot for a motion debate on the Report of the Subcommittee on Hawker Policy

(LC Paper No. CB(4)38/15-16)

22. <u>Mr Tommy CHEUNG</u>, Chairman of the Panel on Food Safety and Environmental Hygiene ("the FSEH Panel"), said that in view of wide public concern over hawker policy and its implementation, the FSEH Panel had endorsed the recommendation of the Subcommittee on Hawker Policy ("the former Subcommittee") to seek HC's support for priority allocation of a debate slot under rule 14A(h) of the House Rules to Mr Steven HO, as Chairman of the former Subcommittee, for moving a motion for debate on the Report of the former Subcommittee ("the Subcommittee Report") at the Council meeting of 11 November 2015. The debate would provide an opportunity for Members to express views on the subject and for the Administration to respond.

23. <u>Members</u> agreed to the priority allocation of a debate slot to Mr Steven HO for moving a motion on the Subcommittee Report at the Council meeting of 11 November 2015. <u>Members</u> also agreed to the FSEH Panel's proposal that in addition to the debate on the Subcommittee Report, only one other debate on a motion without legislative effect should be held at the Council meeting.

IX. Any other business

24. There being no other business, the meeting ended at 2:43 pm.
