#### Paper for the House Committee meeting on 24 June 2016

Report of the Subcommittee on Public Health and Municipal Services (Fees and Charges) (Museums) (Amendment) Regulation 2016

#### **Purpose**

This paper reports the deliberations of the Subcommittee on Public Health and Municipal Services (Fees and Charges) (Museums) (Amendment) Regulation 2016 ("the Subcommittee").

#### **Background**

- 2. According to the Administration, the month-long free admission to the Leisure and Cultural Services Department ("LCSD") museums¹ launched in January 2016 under the "Appreciate Hong Kong" Campaign was well received by the public. To further promote the appreciation of art, culture, history and science, as well as to widen the audience base, the Chief Executive announced in his 2016 Policy Address that the Government would make free admission to permanent exhibitions of designated museums of LCSD a standing practice.
- 3. Under the new initiative, the following changes will be made to the existing arrangements for the seven fee-charging designated museums<sup>2</sup>:
  - (a) all visitors should be allowed free admission to permanent

exhibitions of five fee-charging designated museums, namely the Hong Kong Museum of Art, Hong Kong Heritage Museum, Hong Kong Museum of History, Hong Kong Museum of Coastal Defence and Dr Sun Yat-sen Museum;

- (b) full-time students should be allowed free admission to permanent exhibitions of the Hong Kong Science Museum ("HKScM") and the Hong Kong Space Museum ("HKSpM") (except the Space Theatre of HKSpM), with a view to enhancing the promotion of science and astronomical knowledge among students;
- (c) to complement the arrangement in paragraph 3(b) above, the fees for admission to permanent exhibitions of HKScM by visitors other than full-time students should be reduced by 20%;
- (d) the charges of annual museum passes should be reduced by 50%, because visitors would enjoy free admission (or admission at reduced fees) to permanent exhibitions of the fee-charging museums under the new initiative. All other museum passes (i.e., half-yearly, monthly and weekly passes) should be abolished in anticipation of significantly lower demand after the implementation of free admission; and
- (e) the existing free admission arrangement for all visitors on Wednesdays and International Museum Day, Hong Kong<sup>3</sup>, should be formalized.
- 4. The arrangements and fee levels for admission to permanent exhibitions of LCSD museums and museum passes before and after the implementation of the free admission initiative are set out at **Appendix I**.

# Public Health and Municipal Services (Fees and Charges) (Museums) (Amendment) Regulation 2016 ("the Amendment Regulation") (L.N. 84 of 2016)

5. The Amendment Regulation is made by the Secretary for Home Affairs under section 124J(1) of the Public Health and Municipal Services Ordinance (Cap. 132) to amend the Public Health and Municipal Services (Fees and Charges) (Museums) Regulation (Cap. 132CK) in order to give effect to the changes in paragraph 3 above.

- 6. The Amendment Regulation was gazetted on 20 May 2016 and tabled at the Legislative Council on 25 May 2016 for negative vetting.
- 7. The Amendment Regulation will come into operation on 1 August 2016.

#### The Subcommittee

- 8. At the House Committee meeting on 27 May 2016, Members agreed to form a subcommittee to study the Amendment Regulation. The membership list of the Subcommittee is at **Appendix II**.
- 9. Under the chairmanship of Dr CHIANG Lai-wan, the Subcommittee held a meeting with the Administration on 13 June 2016. The Subcommittee has also invited the public and the three Museum Advisory Panels<sup>4</sup> to provide written submissions on the Amendment Regulation. A list of individuals/organizations who/which have provided written submissions is at **Appendix III**.

#### **Deliberations of the Subcommittee**

Request for free admission to permanent exhibitions of the seven fee-charging museums of LCSD<sup>5</sup>

- 10. Members in general welcome the new initiative of free admission. Miss CHAN Yuen-han and Mr Christopher CHUNG, however, consider that all visitors should be allowed free admission to permanent exhibitions of all existing seven fee-charging museums instead of only five designated ones (see paragraph 3(a) above). They have urged the Administration to allow the public, instead of only full-time students, free admission to permanent exhibitions of HKScM and HKSpM as well. According to the Amendment Regulation, among the seven fee-charging LCSD museums, HKScM and HKSpM will admit only full-time students free-of-charge to their permanent exhibitions.
- 11. The Administration has advised that the proposal is made taking into consideration the capacity constraints of HKScM and HKSpM<sup>6</sup>, and the objective of enhancing the promotion of science and astronomical knowledge

among students. The Administration has explained that given the larger number of interactive exhibits in HKScM and HKSpM, if the number of visitors of the two museums is significantly increased, the queuing time for operating the interactive exhibits will be lengthened, thus giving rise to a crowded and noisy environment which will affect the quality of learning experience to be gained by visitors. Furthermore, in light of the increased damage rate of interactive exhibits in HKScM during the free admission period under the "Appreciate Hong Kong" Campaign, the Administration considers it necessary to pay heed to the capacity constraints of HKScM and HKSpM in determining the number of visitors which the museums can accommodate under the new initiative, in order to keep the interactive exhibits in good condition and to ensure a safe and pleasant visit for the visitors.

- 12. The Administration has further advised that although only full-time students will be allowed free admission to permanent exhibitions of HKScM and HKSpM, the arrangement for free admission to museum on Wednesdays and International Museum Day, Hong Kong, will be maintained. Besides, the existing mechanism for fee-waiver applications will remain valid for schools, charitable and non-profit making organizations. Hence, all members of the public will still have the opportunity to enjoy free admission to permanent exhibitions of HKScM and HKSpM under the new arrangements. The Administration has explained that it aims to encourage more visits to HKScM and HKSpM but intends to do so progressively.
- Miss CHAN Yuen-han and Mr Christopher CHUNG, however, consider that it is far from satisfactory to allow only full-time students free admission to permanent exhibitions of HKScM and HKSpM, and the arrangement is not in line with the objective of encouraging more visits to museums for building a wider audience base. Miss CHAN Yuen-han has expressed the view that it is a common international practice that local people are not charged for admission to the public museums in their countries. She, together with some other members including Mr MA Fung-kwok and Mr Christopher CHUNG, have suggested that the Administration may implement crowd control measures (e.g., online reservation of tickets and viewing sessions) which may also serve the purpose of regulating the flow of visitors. The Administration has explained that arrangements to distribute tickets for visits to HKSpM by sessions had been made in the past, but it was found that some visitors who had obtained tickets did not show up while those without tickets had to wait for entry, leading to disputes over the admission arrangements. Administration has stressed that given the larger number of interactive exhibits in HKScM and HKSpM, the quality of learning experience will be affected if too many visitors are admitted at the same time. Moreover, at present, the admission rate of HKScM is not low.

- 14. Some other members including Dr CHIANG Lai-wan and Mr YIU Siwing have also expressed concern that if all members of the public are allowed free admission to permanent exhibitions of HKScM and HKSpM, many people will be attracted to visit these museums. As a result, visitors will have to queue up for a long time for operating the interactive exhibits or using other museum facilities, and the quality of learning experience will deteriorate.
- 15. The Administration has explained that as it is the first time to allow all visitors free admission to permanent exhibitions of five designated museums, the Administration intends to conduct a review one year after the Amendment Regulation comes into operation. In light of the operational experience and review outcome, the Administration will further explore the feasibility of allowing all visitors free admission to permanent exhibitions of HKScM and HKSpM. The Administration has undertaken to report the outcome of the review to the Panel on Home Affairs. Mr IP Kin-yuen has expressed support for the approach as he considers it fair to first assess the impact of the new arrangements on museum operation before making a decision on the matter. He considers it important to ensure a safe and pleasant visit for the visitors.
- 16. Dr Kenneth CHAN has suggested that to encourage museum visits and promote the appreciation of culture, history and science, LCSD should not only resort to free admission or fee reduction but also seek to enhance the quality of museum service by conducting studies to collect useful data for its service planning. At the request of Dr CHAN, the Administration has provided the "Corporate Business Plan of LCSD Museums for 2015-2020 and Annual Plans of Individual Museums for 2015-2016" for members' reference.

#### **Group tickets**

17. Mr YIU Si-wing has suggested that the existing arrangement that groups of 20 persons or above can enjoy a 30% discount on standard tickets should be revised. He considers that groups of 10 persons or above should be entitled to enjoy the discount. In his view, reducing the group size will facilitate the tourist industry as there are often just over 10 participants in a tour. The Administration has advised that the fee levels for admission to museums are reviewed as a package and it is not suitable to revise any particular item separately. That said, the Administration has undertaken to consider Mr YIU's suggestion in the next admission fee review for museums.

#### Recommendation

18. The Subcommittee does not object to the Amendment Regulation. The Subcommittee and the Administration have not proposed any amendment.

#### **Advice sought**

19. Members are invited to note the deliberations of the Subcommittee.
