 - according to paragraph 11 of the Legislative Council Brief on the Road Traffic (Parking) (Approved Cards) (Amendment) Notice 2016, it was mentioned that the Administration was exploring the use of payment by phone platform ("PPP") for payment of parking meter fees. Upon payment by registered approved card/device at the parking meter physically, the user could make subsequent payment for additional parking time up to the Longest Parking Period of the concerned parking meter by making a phone call or through mobile application. In this regard,
 - (a) the latest progress and timetable of the trial on the PPP application; and
 - (b) details of the mechanism to ensure that the subsequent payment(s) for additional parking time could be limited up to the Longest Parking Period.
