Action

I. Election of Chairman

Mr SIN Chung-kai was elected Chairman of the Subcommittee.

2. <u>Members</u> agreed that there was no need to elect a Deputy Chairman.

II. Meeting with the Administration

[File Ref: L.N. 237 of 2015, Legislative Council Brief issued by the Food and Health Bureau and the Department of Health in December 2015, LC Paper Nos. LS17/15-16 and CB(2)564/15-16(02) to (03)]

3. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

Follow-up actions required of the Administration

Admin 4. <u>The Administration</u> was requested to -

in respect of the proposal of designating the eight bus interchanges located at eight tunnel portal areas (i.e. Lion Rock Tunnel Bus Interchange, Cross-Harbour Tunnel Bus Interchange, Eastern Harbour Crossing Bus Interchange, Shing Mun Tunnels Bus Interchange, Tate's Cairn Tunnel Bus Interchange, Western

Harbour Crossing Bus Interchange, Tai Lam Tunnel Bus Interchange and Tsing Sha Highway Bus Interchange) as no smoking areas ("NSAs"),

- (i) advise the rationale for prioritizing the designation of these eight bus interchanges, but not other bus interchanges and tunnel portal areas, as NSAs in the current legislative exercise, with particular reference to the statistics on pedestrian flow at these locations;
- (ii) provide layout plans and photos showing the boundaries of NSAs and, where appropriate, the areas where smoking was not prohibited in the vicinity of these eight bus interchanges;
- (iii) advise whether, and if so, what facilities would be provided at areas where smoking was not prohibited as referred to in item (ii) above for the convenience of smokers; and
- (iv) advise the measures to be implemented by the Tobacco Control Office to ensure effective enforcement of the smoking ban at NSAs of these eight bus interchanges;
- (b) advise the way forward, including the timetable, for expanding NSAs to other bus stops; and
- (c) provide for members' reference findings of the Administration's past study on the technical feasibility on setting up separately ventilated smoking rooms to segregate smokers and non-smokers.

The way forward

5. The Chairman invited members' views on whether there was a need to extend the scrutiny period of the Smoking (Public Health) Ordinance (Amendment of Schedule 2) Order 2015 ("the Amendment Order") from the Council meeting of 13 January 2016 to that of 3 February 2016, so as to allow more time for the Subcommittee to study the Amendment Order. As there were divergent views among members, a vote was taken on the matter. A majority of members present voted in favour of the Subcommittee extending the scrutiny period of the Amendment Order and no members voted against it. The Chairman declared that given the voting result, he would give notice to move a proposed resolution at the Council meeting of 13 January 2016 to extend the scrutiny period of the Amendment Order.

Action

6. <u>Members</u> noted that if the proposed resolution for extending the scrutiny period of the Amendment Order was dealt with and passed at the Council meeting of 13 January 2016, the period for amending the Amendment Order would be extended to the Council meeting of 3 February 2016; otherwise, the period for amending the Amendment Order would expire at the Council meeting of 13 January 2016. <u>Members</u> agreed that even in the case of the latter, the Subcommittee should hold further meeting(s) to discuss the Administration's written response to issues raised by members at the meeting, and to receive views from the public on the Amendment Order. In line with usual practice, a general notice would be posted on the Legislative Council website and invitation letters would be issued to the 18 District Councils to invite views on the Amendment Order.

(*Post-meeting note*: With the concurrence of the Chairman, the second meeting of the Subcommittee has been scheduled for 25 January 2016 at 9:00 am to meet with the Administration and to receive views of the public on the Amendment Order.)

7. <u>Members</u> also agreed that a site visit to the Cross-Harbour Tunnel Bus Interchange and the Shing Mun Tunnels Bus Interchange, which were proposed to be designated as NSAs under the Amendment Order, and a bus interchange in Sam Shing of Tuen Mun should be arranged. <u>The Chairman</u> said that the Clerk would follow up with the Administration on the arrangements for the site visit and members would be informed of the details in due course.

(*Post-meeting note*: With the concurrence of the Chairman, a site visit to the Bus-Bus Interchanges on Tuen Mun Road, the Shing Mun Tunnels Bus Interchange and the Cross-Harbour Tunnel Bus Interchange has been scheduled for 1 February 2016.)

As a further step, the Amendment Order sought to designate eight bus interchanges located at eight tunnel portal areas as new NSAs given that TCO had received a number of complaints in this regard.
