# 1. Update on the protection of endangered species and biodiversity in Hong Kong

The Administration will brief members on the following -

- (a) the Government's efforts on the protection of endangered species;
- (b) the latest initiatives on ivory control as announced in the Policy Address; and
- (c) the Biodiversity Strategy and Action Plan public consultation.

The subject was raised by Dr Kenneth CHAN at the meetings on 16 October 2012, 21 July 2015 and 15 October 2015, in response to concerns from conservation groups on illegal ivory trade and calls from various groups on stepping up of measures to conserve/protect endangered fauna and flora species in Hong Kong, e.g. protection of incense trees and smuggling of totoba fish bladders.

Referral arising from the meeting between Duty Roster Members and "大澳環境及發展關注協會、'救救土沉香,瀕危滅絕中' 網上群組、活力南丫島、環保及生態保育協會、一群新界區 關注土沉香的居民、一群大嶼山關注土沉香的居民及一群南 丫島關注土沉香的居民" on 19 May 2014 regarding the protection of Incense Trees in Hong Kong (LC Paper No. CB(1)176/14-15(01) issued on 6 November 2014).

Letter dated 4 March 2015 from Ms Claudia MO requesting the Panel to discuss issues related to the illegal trading of endangered species in Hong Kong (LC Paper No. CB(1)616/14-15(01) issued on 6 March 2015).

Letter dated 3 November 2014 from Dr Elizabeth QUAT requesting the Panel to discuss issues related to illegal ivory trade in Hong Kong (LC Paper No. CB(1)190/14-15(01) issued on 6 November 2014).

At the meeting on 23 March 2015, Mr Albert CHAN requested the Administration to provide information on the sale of ivory by licensed hawkers in its discussion paper.

At the meeting on 2 June 2015, Ms Cyd HO requested the Panel to discuss issues related to the smuggling of totoaba fish bladders (Submission from Greenpeace East Asia on the subject was issued vide LC Paper No. CB(1)965/14-15(01) on 8 June 2015).

At the meeting on 15 October 2015, Mr Steven HO requested to be briefed on how the authorities would combat the problem of illegal felling of incense trees.

The Administration will brief the Panel on the progress of formulating the approach and methodology for conducting the review on AQOs.

At the meeting on 2 June 2015, Ms Cyd HO requested the Administration to provide information on the effectiveness of different air quality improvement measures in attaining the prevailing AQOs by 2020 in its discussion paper. At the meeting on 15 October 2015, Ms Cyd HO requested the Administration to provide details on the schedule, preparation work, approach and methodology for the next review on AQOs. 5. Trial of hybrid buses by franchised bus companies – interim March 2016 report (tentative) The Panel will be briefed on the interim assessment of the performance of hybrid buses of the franchised bus companies under full subsidy of the Government on trial in Hong Kong. Application of the "Pollutants in the Atmosphere and their 6. Q1 2016 Transport over Hong Kong" ("PATH") modelling system (tentative) The Administration will brief the Panel on the progress of launching the new PATH modelling system for air quality assessment. At the meeting on 15 October 2015, Dr Kenneth CHAN requested the Administration to brief Panel members on the progress of launching the new PATH modelling system for air quality assessments under the environmental impact assessment mechanism. Mr Dennis KWOK wrote to the Chairman on 20 October 2015 (LC Paper No. CB(1)43/15-16(01) issued on 23 October 2015) requesting the Panel to discuss the subject. 7. **Marine conservation** Q2 2016 (tentative) The Administration will report on the latest efforts on marine conservation, progress on fishing ban in marine parks, and

Pursuant to the discussion at the Panel meeting on 25 June 2014 on the subject of "Impact of construction works on important species, marine ecology and the fisheries industry", members wish to follow up the cumulative impacts of the planned marine works projects in the western waters of Hong Kong (as mentioned in LC Paper No. CB(1)2004/13-14(01)) on marine ecology as well as the progress of respective mitigation measures and restoration works.

Dr Kenneth CHAN wrote to the Panel Chairman on 10 February 2015 (LC Paper No. CB(1)540/14-15(01)) proposing discussion on the impacts of large-scale infrastructure projects and sea transport on marine ecology.

As it was reported by the media that a contractor of the construction works of the Hong Kong-Zhuhai-Macao Bridge ("HKZMB") project had illegally discharged polluting effluent directly into the sea, causing adverse impacts on the habitat of Chinese white dolphins, at the meeting of 15 October 2015, Mr Albert CHAN requested the Administration to give a full account of the incident and update Panel members on the impacts of the marine works projects, including the HKZMB project and the Three-Runway System project at the Hong Kong International Airport, on marine ecology.

### 8. PWP Item No. 5173DR – Development of Organic Waste Treatment Facilities Phase 2

The Administration will seek the Panel's support for the proposal to upgrade the development project to Category B+ before commencement of tendering.

### 9. Handling of imported recyclables

Members will be briefed on measures/initiatives on import/export controls on recyclables since the last report to the Panel in July 2013 and March 2014.
