# Hong Kong Examinations and Assessment Authority (HKEAA) in 2010-2015 regarding the assessment items of Territory-wide System Assessment (TSA)

A total of six complaints regarding the assessment items of TSA were received by HKEAA between 2010 and 2015. A summary on these complaints is set out in the table below:

1	2010	2009 Primary 3 English Language – Reading	A teacher complained that the use of "to" after "spend" was incorrect.	Not substantiated. HKEAA replied to the complainant and explained the rationale.
2	2010	2010 Primary 3 English Language – Reading	A teacher complained that i) the reading texts were lengthy; ii) the assessment time was long; and iii)the use of "if" clause and passive voice was beyond the curriculum of Key Stage 1.	Not substantiated. HKEAA replied to the complainant and explained the rationale.
3	2012	2012 Secondary 3 English Language – Writing 2012	A secondary school principal complained about the use of the word "cheongsam". It was considered that students who did not speak Chinese would be made disadvantaged.	Not substantiated. HKEAA replied to the complainant and explained the rationale.
