The Administration undertook to consult the trade and the Panel when the draft CoP was ready.

During the course of deliberations, the Subcommittee made a number of recommendations for enhancing the operating environment and business competitiveness of public markets (please refer to paragraph 36 of the Subcommittee's report (LC Paper No. CB(2)2142/14-15(01)) for details). In recommending that the Panel should follow up with the Administration the various issues raised therein, the Subcommittee specifically requested the Administration to consult the Panel on its proposals, if any, for rental adjustment mechanism for public market stalls in the first quarter of 2017 at the latest (paragraph 31 of the report refers).	
The Administration intends to revert to the Panel on this issue in the 2 nd quarter of 2016.

Members noted that the Administration would engage relevant stakeholders (including seafood traders and importers) and seek their views on the proposed control scheme.

WONG expressed concerns about the regulation of animal feed for livestock and cultured fish and the presence of veterinary drug residues, including antibiotics, in meat and aquatic products for human consumption. She considered that the Panel should discuss these issues at a Panel meeting.

In her letter dated 9 December 2015 (LC Paper No. CB(2)422/15-16(01)), Dr WONG reiterated her concerns and requested the early discussion of the item.

15. Public consultation on the proposed regulation of heavy metals in food

1st half of 2016

At the meeting on 9 October 2014, Dr Hon Helena WONG expressed concern about the safety standards for heavy metals in food and urged the Administration to review the relevant legislation for regulating the presence of heavy metals in food. She hoped that the Panel would discuss the subject matter at a Panel meeting.

The Administration plans to launch a public consultation and to brief the Panel on the subject in the 1st half of 2016.

The Administration undertook to revert to the Panel when the outcome of the consultancy study was ready.	
At the meeting on 15 October 2015, Hon Steven HO expressed a wish that arrangements be made for early discussion of this subject.	
19. Public consultation on the proposed regulation of cooked meat	To be confirmed
At the special meeting on 3 September 2014, members expressed concern about inadequate regulation of cooked meat and considered that the subject should be followed up by the Panel. The Administration

Hon WONG Kwok-hing requested the Administration to provide the Panel with a policy paper on the subject in the 2014-2015 session.</p> <p>At the meeting on 9 October 2014, Dr Hon Helena WONG hoped that the Administration would brief the Panel as early as possible on the progress of the review on legislation relating to the regulation of cooked meat.</p>

LEUNG expressed concern about problems caused by upstairs bars and the Liquor Licensing Board's considerations in assessing liquor licence applications from them. She suggested the Panel to continue to follow up the subject.

At the meeting on 8 April 2014, members noted the research report on "Liquor licensing system in selected places" prepared by Research Office, Information Services Division of the LegCo Secretariat. Hon Tommy CHEUNG suggested the Panel to discuss the subject of liquor licensing system in Hong Kong and to invite deputations from the trade concerned to give views at a future meeting.

23. Safety of food for pet animals

At the meeting on 10 October 2013, Hon CHAN Chi-chuen suggested that the subject of the safety of food for pet animals be discussed at a future Panel meeting. Hon CHAN had written a letter to the Panel Chairman in late April 2014 expressing concern about the presence of harmful substances in pet food (LC Paper No. CB(2)1429/13-14(01)). The Administration's response to the issues of concern raised in Hon CHAN's letter was issued to members on 5 May 2014 (LC Paper No. CB(2)1429/13-14(02)).

In his letter dated 20 July 2015 (LC Paper No. CB(2)1958/14-15(01)), Hon CHAN Hak-kan also suggested the Panel's discussion of the subject matter.

At the meeting on 15 October 2015, Dr Hon CHIANG Lai-wan expressed a wish that when the Panel discussed the safety of food for pet animals, arrangements be made for discussion of the safety of medicine for pet animals as well.

In his letter dated 15 October 2015 (LC Paper No.

<p>CB(2)52/15-16(01)), Hon CHAN Chi-chuen reiterated his concerns about the safety of food for pet animals and the absence in Hong Kong of legislation to regulate the safety of pet food products. Hon CHAN requested the Panel to discuss the relevant issues as early as possible.</p>	
<p>24. Ancillary facilities for storage and distribution of chilled meat and poultry</p>	To be confirmed
<p>At the meeting on 9 October 2014, Hon Michael TIEN expressed concern about the lack of ancillary facilities for wholesaling of chilled meat and poultry. He pointed out that the trade had made repeated requests for the setting up of an approved distribution and storage centre by the Government for the chilled meat and poultry with a view to reducing food safety risks. He hoped that the Panel would follow up the subject matter.</p>	
<p>At the meeting on 15 October 2015, Hon Steven HO and Hon Michael TIEN both expressed concern about the slow progress of the Administration in taking forward the initiative of setting up an approved distribution and storage centre for chilled meat and poultry. They requested for early discussion of the subject matter by the Panel.</p>	
<p>25. Regulating and monitoring the activities of oyster culture in Hong Kong</p>	To be confirmed
<p>At the meeting on 9 February 2010, in the light of the concerns raised by Hon WONG Yung-kan, a suggestion was made that the issue of regulating and monitoring the activities of oyster culture within Hong Kong waters should be discussed by the Panel at a future meeting.</p>
