#### 15. Impact of financial savings on civil service establishment

At the Panel meeting on 15 October 2015, Hon LEE Cheuk-yan proposed to discuss the impact of the Government's request to all policy bureaux and departments to deliver 1% savings on their respective annual operating expenditure in 2016-2017 and 2017-2018 on civil service establishment at the November 2015 Panel meeting.

The Administration has advised that it had already explained at the Panel on Public Service meeting on 16 March 2015 that the expenditure control measures were to take timely action to ensure sustainability of public finance and to re-allocate resources saved for coping with new public services. Under the measures, B/Ds should introduce efficiency measures through re-engineering and re-prioritization but could seek for creation of new posts for new services or improvements to services with justification (paragraphs 9 and 10 of the minutes of the said meeting refers). This position of the Administration has not changed and hence the Administration considers that there may not be a need to discuss the subject matter again at the November 2015 Panel meeting.

## 16. Criteria for civil servants and staff of subvented organizations to undertake overseas duty visits and the associated subsistence allowance

At the Panel meeting on 15 October 2015, Hon IP Kin-yuen proposed to discuss the issue of the criteria for civil servants and staff of subvented organizations to undertake overseas duty visits and the associated subsistence allowance.

The Administration will provide an information note to the Panel on the criteria for civil servants to undertake overseas duty visits and the associated subsistence allowance provision. The Panel Secretariat will follow up with the relevant bureaux regarding the arrangements for staff of subvented organizations as they are outside the policy purview of CSB.

#### 17. Implementation of the five-day week in the Government

At the meeting on 10 October 2013, Hon TANG Ka-piu proposed and members agreed to discuss the implementation of five-day week in the Government at a future meeting.

The Administration has advised that it will report to the Panel on the implementation of five-day week in the Government, following the completion of its survey on such implementation conducted in September 2014.

### 18. Meal break arrangement for the Ambulanceman Grade in the Fire Services Department

In response to a submission dated 7 May 2014 from the Hong Kong Fire Services Department Ambulancemen's Union requesting the Panel to discuss the meal break arrangement for the Ambulanceman Grade in the Fire Services Department (LC Paper No. CB(4)654/13-14), the Panel agreed at its meeting held on 19 May 2014 to discuss the issue at a future meeting.

The Administration's response on the issue raised in the submission (LC Paper No. CB(4)775/13-14) dated 4 June 2014 was issued to members on 6 June 2014.

## 19. Application of the findings of the Pay Level Survey to Government-funded public bodies

Hon LEE Cheuk-yan wrote to the Panel Chairman on 23 October 2015 requesting that the Panel should hold an urgent meeting to discuss the application of the findings of the Pay Level Survey to Government-funded public bodies.

CSB has advised that these public bodies are outside its policy purview and suggested that, as the remuneration and subvention policies for individual subvented organizations may be different, it may be more appropriate for the respective subject Panels of the Legislative Council to follow them up.
