Follow-up to the meeting of 6 June 2016 of the Subcommittee on the Immigration (Unauthorized Entrants) (Amendment) Order 2016

The Legislative Council (LegCo) held a subcommittee meeting on 6 June 2016 to scrutinize the Immigration (Unauthorized Entrants) Order 2016, where members requested the Government to provide supplementary information on certain issues. In response to issues raised in the email of 7 June by the Clerk to the Panel on Security, the Government provides the following supplementary information.

Germany's law on repatriating refugees who have committed crimes

2. According to the announcements by the federal German Government in January 2016¹², Germany planned to introduce legislative amendments to empower its law enforcement agencies to repatriate from Germany those refugees who have committed serious offences. However,

if such persons may be subject to such risks as torture, cruel, inhuman or degrading treatment or punishment, etc. upon repatriation, the German authorities may not repatriate him from Germany. We understand that the relevant amendments have been passed by the Bundestag this March.
