001732 - 002431	Mr CHAN Chi-chuen CS cum WKCDA Board Chairman PSHA	Mr CHAN Chi-chuen sought information on the estimated total costs of the WKCD project, including whether the upfront endowment of \$21.6 billion would be sufficient to cover the costs of developing the Batch 1 and Batch 2 facilities, the estimated costs of developing the Batch 3 facilities, and the estimated costs of implementing the integrated basement and other public infrastructure works ("PIW") which were funded by the Government. CS cum WKCDA Board Chairman advised that: (a) according to WKCDA's latest assessment, the endowment fund and associated investment return would be sufficient to cover the costs of the design and construction of the Batch 1 and Batch 2 facilities, with related facilities including retail, dining and entertainment ("RDE") facilities and other arts and cultural facilities. As the implementation programmes of the Batch 3 facilities would have to be reviewed at a suitable juncture taking into account, amongst other factors, the changing circumstances of the local arts scene and site availability, information on the estimated costs of the Batch 3 facilities was not available at the present stage. Furthermore, the development of Mega Performance Venue/Exhibition Centre ("MPV/EC") and Musical Theatre which were identified with the potential to be commercially viable would be subject to alternative funding options; and

marker		fund the capital works of the main integrated basement as general enabling works to facilitate the development of WKCD. It had been seeking the funding approval of the Legislative Council ("LegCo") for such works separately in accordance with the development programme.	Required
		In reply to Mr CHAN's enquiry about the estimated total cost of the integrated basement, the Permanent Secretary for Home Affairs ("PSHA") advised that the rough cost estimate of around \$23 billion for the integrated basement and the associated PIW was derived in mid-2013 on the assumption that the construction of the whole integrated basement would start in 2014 for completion in one go by 2020. Given the latest phased implementation arrangement, the estimated total amount of funding sought/to be sought for implementing Zones 3A, 3B and 2B of the integrated basement and the associated PIW in the years up to 2016-2017 was about \$10 billion. However, the cost estimates for the remaining portions of the integrated basement (i.e. Zones 2A and 2C), which were to be implemented at a later stage, were not available yet. The ballpark estimate of around \$23 billion should, therefore, not be taken as the ultimate total cost of the whole integrated basement.

		(b) to what extent the development programme of the WKCD project was affected by the delay of the Guangzhou-Shenzhen-Hong Kong Express Rail Link ("XRL") project.	
		CS cum WKCDA Board Chairman advised that:	
		(a) WKCDA had not given up the implementation of the Batch 3 facilities. Indeed, she was increasingly convinced about the importance of WKCD to Hong Kong not only for arts and culture, but also for economic development and opportunities for the youth. In view of the funding gap, WKCDA had been proactively exploring alternative financial arrangements with the Government with a view to identifying alternative funding/financing options for WKCDA to complete all the planned WKCDA facilities under the Development Plan including the Batch 3 facilities. WKCDA had also been working with the Government to identify alternative approaches to take forward MPV/EC and Musical Theatre through some forms of public-private partnership. WKCDA

		aimed to work out and agree with the Government on the alternative financial arrangements before the end of the current term of the Government; and	
		(b) WKCDA had been focusing mainly on the development of the Batch 1 facilities and the Artist Square Development Area ("ASDA") (i.e. mini-WKCD), which was generally not affected by the XRL works in WKCD. While it was anticipated that the XRL project would be completed by 2018, it was unlikely that the works areas in the vicinity could be immediately released for implementation of Batch 3 facilities in WKCD even if the funding issue was resolved. She expected that the XRL project delay would not have significant adverse impact on the implementation of the facilities in WKCD.	
002933 - 003512	Mr MA Fung-kwok CS cum WKCDA Board Chairman	Mr MA Fung-kwok said that while he was pleased to note that the Administration and WKCDA had responded positively to his earlier suggestion of increasing the development intensity of the WKCD site, he was concerned that the capital cost of developing the additional gross floor area ("GFA") for WKCDA facilities was not covered by the upfront endowment and their development was subject to funding availability. He enquired whether the Administration would consider providing further financial support to WKCDA through, for instance, transferring the income generated from the disposal of part of the additional GFA for commercial developments to WKCDA, so as to help WKCDA meet the capital cost of developing the additional GFA for WKCDA facilities and other costs incurred in implementing the WKCD project.	
		CS cum WKCDA Board Chairman responded that the additional GFA allocated to WKCDA would focus primarily on other arts and cultural facilities, as well as RDE uses. The issue of the development and financing approach for those additional GFA would be addressed in the context of the ongoing review by WKCDA and the Government on the financial arrangements for the WKCD project. One possible alternative financing/funding option being explored was granting the development right in respect of some or all of the commercial developments in WKCD to WKCDA with WKCDA's payment of land premium, so as to enable WKCDA to generate income to cover the costs of implementing the WKCD project. Details of the proposed alternative financing/funding option(s) would be reported to LegCo when ready.

		Miss CHAN Yuen-han enquired whether WKCDA had any plans to accelerate the delivery of the RDE facilities in WKCD, so as to generate recurrent income for WKCDA to meet the deficits of running the Batch 1 facilities.	
		The Chief Executive Officer of WKCDA ("CEO, WKCDA") explained that given the integrated design of WKCD, RDE facilities would be included in the Park, the core arts and cultural facilities ("CACF") and the hotel, office and residential ("HOR") developments within WKCD. With a view to bringing in RDE income earlier and enhancing the vibrancy of WKCD, WKCDA had sought to advance the delivery of the RDE facilities within the Park and CACF pending the development of the HOR sites in WKCD. The RDE facilities within the Park, Xiqu Centre, M+ and Lyric Theatre Complex ("LTC") were expected to be delivered alongside the venues in 2017, 2018, 2019 and 2020 respectively. Subject to WKCDA being given the development right in respect of some or all of the commercial developments in WKCD, WKCDA would work on developing the HOR sites and the RDE facilities therein within ASDA and other relevant parts of WKCD.	
004042 - 004742	Deputy Chairman CS cum WKCDA Board Chairman	In response to the Deputy Chairman's enquiry, CS cum WKCDA Board Chairman clarified that the expenses for the promotion of cultural software development would be met by the income to be generated from the RDE facilities developed under the scope of the upfront endowment for the WKCD project. The RDE income would also be used to meet the operating deficits of the arts and cultural facilities.	
		On the Deputy Chairman's enquiry about whether WKCDA had formulated any tentative development and financing approach for those venues requiring alternative funding (i.e. MPV/EC and Musical Theatre), CS cum WKCDA Board Chairman advised that the development of MPV/EC and Musical Theatre was subject to alterative funding arrangements given their potential to operate with a surplus. WKCDA was examining the idea of developing the site designated for MPV/EC through some forms of public-private partnership, taking into account changes in territory-wide requirements in Hong

She supported the Administration and WKCDA seeking additional funding from LegCo for implementing the WKCD project, and enquired whether the Administration and WKCDA had any plan to do so before the end of the current term of the Government. CS cum WKCDA Board Chairman responded that: (a) apart from providing WKCDA with an upfront endowment to implement the WKCD project, the Administration had undertaken to fully fund the capital works of the main integrated basement and had been seeking LegCo's funding approval for the relevant works which would be implemented in phases; and (b) to bridge the funding gap for the WKCD project, WKCDA was proactively exploring alternative financial arrangements with the Government. As compared with the proposal to seek LegCo's approval for funding injection into the original upfront endowment and the proposal to obtain its funding approval for developing the outstanding WKCDA facilities on a project-by-project basis, the Administration and WKCDA considered that the proposal to give the development right in respect of some or all of the commercial developments in WKCD to WKCDA to expand its revenue source would allow greater flexibility for WKCDA facilities in accordance with the integrated development design concept and organic growth approach intended for WKCD.

The cost estimates for the remaining portions of the integrated basement (i.e. Zones 2A and 2C) were not available yet as the handover programme and the mode of development of the sites in these zones were subject to confirmation.	
		The Chairman considered that as the Administration had fully funded the capital works of the main integrated basement, it had, in effect, rendered additional funding support to WKCDA.	
		In response to the Chairman's enquiry about the proposed approach to develop those venues requiring alternative funding, CS cum WKCDA Board Chairman reiterated that only those venues which were identified with the potential to be commercially viable (i.e. MPV/EC and Musical Theatre) were proposed to be developed through some forms of public-private partnership. A possible form of public-private partnership was to engage private developers to construct and operate the venues for a certain period of time, after which the venues would be returned to WKCDA.

She sought confirmation on whether the Administration and WKCDA would continue to adopt such an approach in implementing the WKCD project and if so, whether any review mechanism was in place to ensure that this guiding principle was adhered to throughout the development of WKCD. CS cum WKCDA Board Chairman responded that WKCDA had carefully assessed the demand before taking forward each of the CACF in WKCD and would continue to do so in future. Given the keen demand for performing arts venues in Hong Kong, WKCDA was committed to implementing the Batch 3 facilities including Great Theatre, Music Centre and Medium Theatre I after the relevant parts of the WKCD site had become available and the funding issue had been resolved. Nevertheless, as the development of Musical Theatre and MPV/EC was subject to alternative funding options, the demand for these venues would need to be critically examined. Ms Cyd HO said that while she agreed that the Batch 3 facilities should be implemented as they comprised major venues which were crucial components of the WKCD that had been envisioned, she was of the view that the scale of and the facilities to be included in those venues could be fine-tuned as necessary in the light of the overall position of the arts and cultural development in Hong Kong.

		On Dr CHIANG's concern about the operating expenditure of WKCDA, CS cum WKCDA Board Chairman pointed out that the WKCDA Board had all along attached importance to controlling WKCDA's operating expenditure and would continue to review critically the annual business plan prepared by the management of WKCDA. In respect of the efforts made in controlling staff costs, while WKCDA had an approved staff establishment of 300 according to its business plan for the 2015-2016 financial year, it had engaged only 249 staff members as at March 2016 having regard to actual operational needs. WKCDA had also rigorously controlled the expenditure on consultancy fees, with only 28% of the approved budget for the conduct of consultancy studies in the 2015-2016 financial year expended up to March 2016.

		WKCDA clarified that the construction programme of the integrated basement had taken into account the timetable for the release of the relevant XRL works areas in WKCD previously advised by MTRCL. As MTRCL had recently agreed to hand over to WKCDA the barging area in Zone 3B of WKCD earlier than it had previously proposed, the
