關於:從「基本工程儲備基金」整體撥款中抽出爭議項目獨立審批

如題。正如本委員會成員早於月前發展事務委員會討論相關撥款申請時,已明確表示,是年「基本工程儲備基金」有一定爭議項目,宜抽出獨立審議,亦當場提出動議,並獲通過。其後,政府拒絕理會我等於發展事務委員會之建議,即使民主黨幾位議員再次致函提出要求,亦置若罔聞。政府迄今所作之回覆實不得要領。

綑綁式表決及討論,只適用於無爭議性項目。若將爭議項目與無爭議項目綑綁 表決及討論,則無異消滅立法會監察政府之職能。若然,則政府此一安排,明 顯違反《基本法》,包括第七十三條第三項和第六項,即:

第七十三條

香港特別行政區立法會行使下列職權:

- (三)【根據政府的提案,】批准稅收和公共開支;
- (六) 就任何有關公共利益問題進行辯論;

本人相信,若然如是,政府不但違法,更會進一步撕裂行政立法關係,犧牲市民福祉。畢竟,於是次整體撥款中關係到的至少9,428項目中,本人相信,有逾九千項是無爭議性,可立即通過施行,改善民生;政府實絕不應綑綁討論及表決。

就此,本人作如下建議,懇請政府作嚴肅考慮:
