II. 聽取公眾對垃圾收集及資源回收提出的意見 (下午2時30分至6時55分)

敦促政府公平公正處理即將推行的四電一腦回收徵費政策

就有關舊電器及電子設備生產者責任徵費及正在利用超過5億公帑在屯門環保園建造俗稱大 WEEE 廠項目，政府一直理直氣壯謂大 WEEE 廠不會與回收業界競爭，只會處理無甚價值而業界不願回收的廢舊電器如十年以上的電櫃、冷氣機或舊款大電視機等。然而大 WEEE 廠經營及管理的中標者以本港大財團作背境的 ALBA IWS 公司則高調在社區各大機構及學校推廣有價的電器及電腦設備回收項目，令人疑慮 ALBA IWS 是利用關係及公眾資源去牟利，有欠公允。例證請參閱附頁一。現促請主席督促環保署必須嚴格審查 ALBA IWS 的運作，以免魚目混珠利用公帑作私營企業牟利工具，對回收業界造成重大打擊。
