尊敬的邵家輝議員：

本公司是香港其中一家煙草代理及分銷商，代理銷售數多種香煙產品。

政府於上月 23 日舉行簡介會向煙草業界介紹控煙法例的修訂建議，包括擴大健康忠告圖像的面積應至少佔煙草產品封包及零售盛器最大的兩個表面的 85%，但本公司一直沒有收到有關信函，因此未能有機會參與。

本公司其後去信要求當局再次安排另一輪簡介會，政府只回覆“抱歉”，但未能證明政府在 11 月初有通知我司參加 11 月 23 日的簡介會，但局方堅決拒絕安排接見我司代表。(隨函附上政府回覆信以作參考)

有關建議將對煙草零售及分銷商產生嚴重影響。本公司前線員工每天需要處理的貨物數以萬包計，若將品牌資訊給以 85% 覆蓋，分辨不同品牌將變得極為困難。此外，當消費者無法辨認煙草產品的品牌與款式，我們擔心顧客將更容易受到私煙吸引，從而鼓催香港已經頗為龐大的走私香煙市場。

故此，本公司懇請閣下代表像我們這樣的本地分銷商向當局溝通，請求當局舉行一次公開的聽政會，好讓各持份者均有機會發聲和表達他們的關注點和運作困難。


**Briefing Session on 23 November 2016 for the Technical Issues regarding
Health Warnings on Tobacco Product Packets**

I refer to your letter to the Food and Health Bureau dated 24 November 2016 which we received on 1 December 2016.

We had earlier received the submission dated 12 July 2016 from your company, SUTL Corporation (Hong Kong) Ltd. The views expressed in the submission, including the concern on the proposed adaptation period, are noted.
