Any delay in establishing TIA would affect the interests of consumers and reputation of Hong Kong's travel industry. Besides, the proposal by some deputations and individuals on the establishment of a tourism bureau could not replace the need for the legislation to regulate the trade;

		(b) in view of the growing popularity of buying travel products through on-line travel agents amongst Hong Kong citizens, the proposal of bringing on-line travel agents under the regulation of the new legislation aimed to afford greater protection to outbound travellers of Hong Kong and ensure a level playing field for both on-line and traditional travel agents. The Administration added that the nature of travel agent generally was that travel services were only obtained for consumers after the receipt of payments, so it was important to ensure the proper conduct and professionalism of the trade. Regardless of any new mode of business operation, the need to safeguard consumers' interests could not be compromised. Obtaining a licence was a prerequisite for carrying on travel agent business and the procedures involved were not complicated;	
		(c) the Administration noted the concern of some trade members about the legal responsibilities to be borne by travel agents and frontline practitioners in view of the provisions in the Bill that sought to criminalize certain unscrupulous acts in the travel trade. The Administration would ensure that legal responsibilities of travel agents and frontline practitioners would be clearly delineated in drafting the relevant subsidiary legislation. In cases of coerced shopping, key considerations would include whether the travel agent and tourist guide had committed the act of coerced shopping, and whether all reasonable steps had been taken to avoid the commission of the act. The Administration stressed that all suspected non-compliance and criminal cases would be investigated fairly and impartially by TIA;	
		(d) the Administration noted the varying views on whether the relationship between travel agents and tourist guides/tour escorts should be regulated to be an employment one through the new legislation. Given that Hong Kong was a free market, that no legislation mandated an employment relationship for any other sectors, and that general matters on the relationship between employers and employees could be dealt with by the existing labour-related legislation, the Administration considered it inappropriate to mandate an employment

In response to the enquiry of Mr POON, the Administration confirmed that TIA members would be appointed by the Chief Executive of the Hong Kong Special Administrative Region instead of being recommended by the trade.
