Clauses 147 and 148 respectively require a licensed travel agent to pay the Travel Industry Authority levy and the Travel Industry Compensation Fund levy in respect of every outbound fare received by the travel agent. The Administration was requested to clarify whether payments paid by outbound travellers outside Hong Kong in relation to an outbound tour (e.g. tips for tourist guides/tour escorts and fees for optional activities/transportation arrangement) and outbound fares paid to on-line travel agents based outside Hong Kong would be subject to the levies.

		The Administration advised that all relevant factors including risk assessment, operations of travel agents, the financial position of TICF and levy rate, consumer protection, etc. would need to be holistically considered and weighed when reviewing the relevant arrangements. The Administration added that, as explained at previous meetings, the Bill had already enhanced the protection for outbound travellers under TICF by defining "outbound package" as a combination of two or more outbound travel services and arrangements relating to the same tour (i.e. no matter whether such services and arrangements are bought at the same time or at different times from a travel agent).

		On the Chairman's concern about the investment return of TICF, the Administration said that TIA would adopt a prudent strategy in managing TICF with a view to making ex gratia payments only when necessary while earning a reasonable investment return.	
		In response to Mr LAU Kwok-fan's enquiry, the Administration advised that travel agents were currently liable to pay TIC levy and TICF levy under the Travel Agents Ordinance (Cap. 218). TIC levy would be replaced by TIA levy upon the full commencement of the ordinance. The fund accumulated under TICF would be transferred to and managed by TIA by then.

After the passage of the Bill by the Legislative Council, the Administration would commence preparations for implementing the new regulatory regime, including seeking resources to set up TIA and enable it to recruit staff to handle tasks including, among other things, formulation of subsidiary legislation, guidelines, directives, codes of conduct and other administrative arrangements.
