015612 - 020401	Chairman Admin	The Administration's response to the major concerns and issues raised by the deputations:  (a) as had been emphasized during the scrutiny of the Medical Registration (Amendment) Bill 2016 ("the 2016 Bill"), the Medical Council of Hong Kong ("the Medical Council") was operated under professional autonomy. The members appointed by the Chief Executive ("CE") performed the duty of the member of the Medical Council independent of the Government. To address the concerns of some in the medical profession that the number of elected members were less than the number of appointed members, the Medical Registration (Amendment) Bill 2017 ("the Bill") proposed to convert the two seats to be nominated by the Hong Kong Academy of Medicine ("the Academy of Medicine") for appointment by CE to two seats to be elected by the Academy of Medicine in accordance with its regulations or procedures. It should be noted that the number of Fellows of the Academy of Medicine had increased from about 2 500 to 7 500 over the past 20 years. It should also be noted that for the four additional lay members of the Medical Council proposed under the current Bill, three of them were to be elected by recognized patient-related organizations and one of them was to be nominated by the Consumer Council, without appointment by CE. After the passage of the Bill, the details of the patient organizations election arrangements would be set out in a subsidiary legislation to be tabled in the Legislative Council ("LegCo");  (b) under the Bill, the elected members (i.e. being the registered medical practitioner members or lay members) plus the lay member to be nominated by the Consumer Council would account for approximately two-thirds of the membership of the Medical Council, which was what the medical practitioner members would account for half of the membership of the Medical Council, which was what the medical profession had been calling for at the later stage of the last legislative exercise; and

While HA had received nearly 380 applications in its recruitment exercises for non-locally trained medical practitioners with limited registration conducted during the period between 2011-2012 and 2016-2017 to address manpower shortage, only 35 applications were submitted by HA to the Medical Council for approval of limited registration.	
021331 - 021746	Chairman Dr Helena WONG Academy of Medicine Admin	Dr Helena WONG invited deputations' views on Dr Au Yiukai's proposal concerning the composition of the Medical Council as set out in his submission (LC Paper No. CB(2)1841/16-17(02)). Instead of converting the two appointed seats from the Academy of Medicine to elected seats as proposed in the Bill, it was proposed that one appointed seat from HA and one appointed seat from the Department of Health be converted to elected seats for direct general election by all registered medical practitioners.	
		Representative of the Academy of Medicine remarked that the Academy had no established position on the above proposal. At present, the two registered medical practitioners from the Academy of Medicine to be appointed to the Medical Council were nominated and elected by the Council. In response to its Fellows' call for enhancing the transparency of the election, the Academy of Medicine was gauging views from its Fellows on how to elect two representatives, be they served as appointed members or elected members in future, to the Medical Council.	
		The Administration advised that both the legislative proposal and Dr Au Yiu-kai's proposal concerning the composition of the Medical Council had been fully deliberated by the Tripartite Platform on Amendments to the Medical Registration Ordinance.

However, non-locally trained medical practitioners so employed by HKU and CUHK might also have to perform clinical duties according to the need in their teaching, research or hospital work. In the light of the above, he considered that the proposed extension of the maximum validity period and renewal period of limited registration from a period of not exceeding one year to a period of not exceeding three years should only be applicable to those medical practitioners having a specialist qualification comparable to the intermediate examination of the constituent colleges of the Academy of Medicine.	required

		Mr LEUNG Kwok-hung's view that a narrow electorate base and proxy voting were two common factors causing voterigging; and his remark that while the Committee stage proceedings of the 2016 Bill could not be completed before the prorogation of the Fifth LegCo, it provided an opportunity for the medical sector, patient groups and the Administration to have a thorough discussion on the amendments to the Medical Registration Ordinance (Cap. 161).
