I. Meeting with the Administration

[File Ref.: FHCR1/F/3261/92, LC Paper Nos. LS74/16-17, CB(2)1723/16-17(02), CB(2)2098/16-17(01) to (03) and CB(3)628/16-17]

The Bills Committee deliberated (index of proceedings attached at **Annex**).

Admin 2. The Bills Committee requested the Administration to:

- (a) provide information on the countries/regions where the 35 non-locally trained medical practitioners with limited registration employed by the Hospital Authority ("HA") as referred to in paragraph 13 of LC Paper No. CB(2)1824/16-17(02) received their basic medical training;
- (b) in respect of the non-locally trained medical practitioners with limited registration, provide information on the registration status notification mechanism between the Medical Council of Hong Kong ("the Medical Council") and the medical authorities outside Hong Kong which these medical practitioners registered with;
- (c) in respect of the three applications for renewal of limited registration (one submitted by the University of Hong Kong ("HKU") and two submitted by The Chinese University of Hong Kong ("CUHK")) concerning three non-locally trained medical practitioners who did not continue to register with the relevant overseas medical authorities at the time the applications were submitted, provide information on the

reason(s) why HKU and CUHK decided to continue the employment and why the Medical Council approved the applications. According to section 14A(2) of the Medical Registration Ordinance (Cap. 161), one of the requirements for limited registration was that the person concerned satisfied the Medical Council that he/she was registered with an approved medical authority outside Hong Kong;

- (d) provide the guidelines put in place by HKU and CUHK to govern the provision of private patient services by its medical practitioners, including both registered medical practitioners with full registration and limited registration; and
- (e) in respect of those non-locally trained medical practitioners with limited registration employed by HKU and CUHK who had to perform clinical duties, in particular those who were engaged in training and/or short-term exchange programmes,
 - (i) provide the number of complaints, if any, against these non-locally trained medical practitioners in relation to their clinical work which were received by HKU, CUHK and the Medical Council respectively;
 - (ii) the mechanism, if applicable, currently put in place by HKU and CUHK to monitor their clinical performance so as to ensure patient safety; and
 - (iii) advise whether for the sake of patient safety, consideration would be given enhancing to qualification requirements for these non-locally trained medical practitioners, say, by making reference to the relevant requirement employed by HA that the person concerned had to have a specialist qualification comparable to the intermediate examination of the constituent colleges of the Hong Kong Academy of Medicine.

Chairman of the Medical Council and Chairman of the Preliminary Investigation Committee of the Medical Council ("PIC Chairman of the Medical Council") advised that the Medical Council would consider whether the applications for registration as a medical practitioner with limited registration met the requirements set out in section 14A of the Medical Registration Ordinance (Cap. 161) ("the Ordinance"). Chairman of the Medical Council remarked that HKU and CUHK	
		had developed various reciprocal arrangements with other institutions concerning collaborative training, academic exchange and skills transfer. The employment of medical trainees through limited registration under such arrangements was important to the exchanges and training for local medical practitioners.	

005148 - 005923	Chairman Ms Claudia MO Chairman of the Medical Council Admin	Ms Claudia MO's concern that the legislative proposal to extend the period of limited registration of medical practitioners would encourage more medical practitioners who received their medical training in the Mainland to come to practise medicine in HA and the two teaching hospitals under limited registration. Chairman of the Medical Council and the Administration's advice that HA would only employ those non-locally trained medical practitioners who, in addition to their meeting of the statutory requirements for limited registration, possessed a specialist qualification comparable to the intermediate examination of the constituent colleges of the Hong Kong Academy of Medicine ("Academy of Medicine"); had at least three years' working experience in hospitals after completion of internship; and were able to speak fluent English and Cantonese (except for the specialties of anaesthesia, pathology and radiology) to ensure that they had attained the required medical standard for performing frontline clinical work in pressurized areas of public hospitals independently. It should be noted that there was currently no relevant framework for recognizing specialist qualification in the Mainland. On Ms Claudia MO's enquiries concerning the legislative proposal to increase substantially the number of assessors from 14 to up to 140, the Administration advised that there was a need to expand the pool of assessors such that enough Preliminary Investigation Committees ("PIC") and the proposed inquiry panels could be formed to handle complaints within a reasonable time. It was proposed that an assessor would hold office for a period not exceeding three years as specified by the Medical Council. If renominated by the nominating authority concerned, the assessor's would be eligible for reappointment for a further period or periods not exceeding three years each on the expiry of the assessor's period of appointment or reappointment.

It should be noted that whether a medical practitioner with limited registration who had resided in Hong Kong for a continuous period of not less than seven years was eligible for the right of abode in Hong Kong would be subject to the Immigration Ordinance (Cap. 115);	
		(b) the purposes of HA and the two universities in employing non-locally trained medical practitioners with limited registration were different. It was difficult to predict the number of applications for limited registration to be made by non-locally trained medical practitioners after the passage of the Bill; and	
		(c) apart from proposing to extend the validity period and renewal period of limited registration to attract more non-locally trained medical practitioners, in particular those who were local residents, to practise in Hong Kong, the Administration had already increased the number of first-year-first-degree publicly funded training places in medicine to increase the manpower supply at source.

It was believed that HA and the Faculties of Medicine of the two universities would closely monitor the performance of medical practitioners with limited registration they employed.

Where necessary, HKU and CUHK were in a better position to, based on their operational needs, determine any additional requirements in respect of recruitment of non-locally trained medical practitioners with limited registration.

It would be for the Medical Council to determine the length of the	

		validity period or renewal period of limited registration for each application, which would be up to three years if the Bill was passed.

In response to the Chairman and Dr CHENG Chung-tai's enquiry, the Administration advised that the remuneration for the Legal Adviser to the Medical Council was currently capped at \$280,000 per month. On Dr CHENG Chung-tai's concern about the measures to be put in place by the Medical Council for the avoidance of potential conflict of interests by the appointed counsels and solicitors in disciplinary inquiries if the above legislative proposal was passed, PIC Chairman of the Medical Council advised that the Medical Council had mechanism and guidelines in place for handling conflict of interests under inquiries to ensure that each inquiry would be conducted in a fair and impartial manner.

Noting that the number of Fellows in each College of the Academy of Medicine varied from 1 600 to less than 200, Mr SHIU Ka-chun was concerned about how the Academy of Medicine would elect two registered medical practitioners to sit on the Medical Council in accordance with its regulations or procedures. The Chairman's remarks that to his understanding, Fellows of the Academy of Medicine had different views as to whether these two seats should be directly elected by all Fellows or indirectly elected by members of the Council of the Academy of Medicine. The Administration advised that having regard to the principle of professional autonomy, it was considered appropriate for the	
		Academy of Medicine, being a statutory body responsible for medical specialist training, to determine how it would elect the two registered medical practitioners to sit on the Medical Council. PIC Chairman of the Medical Council remarked that the Medical Council currently comprised, among others, seven registered medical practitioners who were members of the Hong Kong Medical Association nominated in accordance with its relevant regulations or procedures and elected by its Council members in accordance with those regulations or procedures.

In reply to Dr KWOK Ka-ki's enquiry about the composition of an inquiry panel, the Administration advised that it was proposed under the Bill that an inquiry panel would comprise three registered medical practitioners and two lay persons. It was considered that the proposed composition was appropriate in order to facilitate the formulation of more than one inquiry panel to handle complaints within a reasonable time. Holding the view that the remuneration for the part-time Legal Adviser to the Medical Council was not on a low side, Dr KWOK Ka-ki considered that in future, the legal advisers engaged by the Medical Council should be on a full-time instead of a part-time basis. The Administration's advice that if the Bill was passed, the Medical Council would consider the appropriate mode of employment of the legal advisers based on the workload.	Admin
