I. Meeting with the Administration

[LC Paper Nos. CB(2)1723/16-17(02), CB(2)2098/16-17(03), CB(2)109/17-18(03), CB(2)152/17-18(01), CB(2)221/17-18(01), CB(2)274/17-18(01) to (03), CB(2)275/17-18(01) and CB(3)628/16-17]

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

Invitation of views

2. <u>Members</u> agreed that the Bills Committee should invite those organizations and individuals who had made oral representation on the Bill on 11 July 2017 to attend the next meeting of the Bills Committee scheduled for 27 November 2017 to give views on the Administration's revised proposal on the composition of the Medical Council of Hong Kong ("the Medical Council"), details of which were set out in LC Paper No. CB(2)109/17-18(03).

Amendments to the Bill

Admin

- 3. <u>Members</u> noted that the Administration would revise its draft amendments to the Bill to the effect that the proposed section 3(6) of the Medical Registration Ordinance (Cap. 161) ("the Ordinance") would also cover the ex-officio members, and the proposed section 3(6A) of the Ordinance would cover any member of the Medical Council other than those described in the proposed section 3(6) of the Ordinance.
- 4. <u>Dr KWOK Ka-ki</u> indicated that in respect of the Administration's proposal to add two seats of registered medical practitioners who were Fellows of the Hong Kong Academy of Medicine ("the Academy of Medicine") being nominated and elected by Fellows of the Academy of Medicine in accordance with the Academy of Medicine's regulations or procedures in the composition of the Medical Council, he might consider proposing amendments to the Bill to the effect that both Fellows and Members of the Academy of Medicine would be entitled to vote in the election for the two seats.

Follow-up actions required of the Administration

- 5. The Bills Committee requested the Administration to:
 - (a) in respect of the proposed new section 3(5AA)(b) of the

Ordinance, gauge and revert in writing on the views of the patient organizations on the proposed arrangement that when a vacancy occurred in the office of a lay member representing the interests of patients and the unexpired term of the office was less than one year, the Medical Council would be empowered to (i) decide whether a person nominated by any lay member of the Medical Council to fill the vacancy represented the interests of patients; and (ii) appoint the person to fill the vacancy based on such nomination; and

(b) revert in writing on the Medical Council's stance on a member's view that the existing mechanism put in place by the Medical Council for handling conflict of interests in disciplinary inquiries might not be able to ensure that each and every complaint would be handled in a fair and impartial manner, with particular regard to the legislative proposal that the size of the pool of lay assessors and medical assessors, to be nominated by the nominating authorities set out in the proposed new Schedule 5 to the Ordinance, would be expanded significantly.

		The Administration's elaboration of its response as set out in paragraphs 6 to 10 in LC Paper No. CB(2)274/17-18(03); and its advice that it would be more appropriate for it to relay members' views to the Director of Health and the Chief Executive of HA that their representatives in the Medical Council should be registered medical practitioners as far as practicable.

		Dr KWOK Ka-ki's view that the Director of Health or his or her representative and the Chief Executive of HA or his or her representative being medical practitioners would ensure that they had the professional knowledge to facilitate the operation of the Medical Council. He might consider moving amendments to the Bill in this regard. The Administration stressed that the appointment of the Director of Health and the recruitment of the Chief Executive of HA were made in accordance with the established mechanism.	
		Referring to the tentative timetable of the Academy of Medicine for collecting views and formulating the regulations or procedures for nominating and electing two Fellows to fill the two proposed registered medical practitioner seats in the Medical Council who were Fellows of the Academy of Medicine being nominated and elected by Fellows of the Academy of Medicine ("the two proposed seats") as set out in paragraph 5 of LC Paper No. CB(2)274/17-18(03), Dr KWOK Ka-ki was concerned about how it could be ensured that no additional thresholds would be imposed by the Academy of Medicine on the nomination and election of the two proposed seats.

		In response to Dr Pierre CHAN's enquiry about the use of the expression "appointed by the Chief Executive" in the English text of the existing sections 3(2)(d) and 3(2)(da) and the proposed section 3(2)(h) of the Ordinance and the expression "to be appointed by the Chief Executive" in the English text of the existing section 3(2)(g) of the Ordinance, the Administration and the Legal Adviser to the Bills Committee confirmed that the two expressions had the same meaning.

While the current proposal of having the two seats being filled by Fellows of the Academy of Medicine nominated and elected by Fellows of the Academy of Medicine was acceptable, he maintained the view that it was necessary to ensure that no additional thresholds would be imposed on the nomination and election of the two proposed seats.

		The Administration's advice that it took the opportunity to repeal the above provision in this legislative exercise as the Court of First Instance of the High Court had handed down its judgement in 2009 that the provision was inconsistent with Article 39 of the Basic Law.	
		In response to Dr Pierre CHAN's enquiry, the Administration advised that no registered medical practitioner had so far been disqualified pursuant to the above provision.

Upon the passage of the Bill, a new piece of regulation subject to negative vetting of the Legislative Council would provide for the procedure and other matters in relation to an election or appointment of these three lay members ("the new regulation").	
		On Dr Pierre CHAN's concern about whether the eligibility requirements for being an elector in these elections could ensure that all relevant patient organizations would be entitled to vote in the elections and prevent vote-rigging, the Administration advised that all patient organizations proved to the satisfaction of the Permanent Secretary for Food and Health (Health) ("the Permanent Secretary") that it met the requirements as specified in paragraph 1(a) to (d) in Annex D to the LegCo Brief, and any other entity recognized and accepted by the Permanent Secretary would also be eligible as an elector. Each elector would be entitled to three votes. The three candidates who obtained the greatest number of votes would be elected.
