I. Meeting with the Administration

[LC Paper Nos. CB(2)833/17-18(01), CB(2)837/17-18(01) to (02) and CB(2)871/17-18(01)]

Amendments to the Bill

- 2. <u>The Bills Committee</u> completed scrutiny of the draft amendments to the Bill to be proposed by the Administration as set out in LC Paper No. CB(2)871/17-18(01). <u>Members</u> did not raise objection to the proposed amendments.
- 3. <u>The Bills Committee</u> requested the Administration to provide after the meeting the final version of its proposed amendments to the Bill for onward circulation to members for consideration. <u>Members</u> agreed that there would be no need to hold another meeting to discuss the paper unless warranted.

The Bills Committee requested the Administration to, after communicating with the Hong Kong Academy of Medicine ("the Academy of Medicine"), revert to the Bills Committee on further details of the proposed nomination and election arrangements for the two additional seats of registered medical practitioners, who were Fellows of the Academy of Medicine being nominated and elected by Fellows of the Academy of Medicine, in the composition of the Medical Council of Hong Kong. In particular, the Academy of Medicine was invited to advise the Bills Committee on its tentative timetable for the nomination and election having taken into account the Administration's plan to resume the Second Reading debate of the Bill at the Legislative Council meeting of 28 March 2018.
- 5. <u>Members</u> agreed that there would be no need to hold another meeting to discuss the above response to be provided by the Administration unless warranted.

- 6. <u>Members</u> agreed that subject to the provision of the final version of the amendments to be proposed by the Administration to the Bill and the written response to be provided by the Administration referred to in paragraph 4 above, the Bills Committee would report its deliberations to the House Committee at its meeting on 16 March 2018.
- 7. <u>Members</u> noted the Administration's intention to resume the Second Reading debate on the Bill at the Council meeting of 28 March 2018 and raised no objection. <u>Members</u> noted that the deadline for giving notice of moving amendments to the Bill, if any, was 19 March 2018.
