I. Confirmation of minutes of meeting

Minutes of 16th meeting held on 24 February 2017

(LC Paper No. CB(2)982/16-17)

The minutes were confirmed.

II. Matters arising

Report by the Chairman on her meeting with the Chief Secretary for Administration

2. <u>The Chairman</u> said that there was nothing special to report.

III. Business arising from previous Council meetings

(a) Legal Service Division report on bill referred to the House Committee in accordance with Rule 54(4)

Cross-boundary Movement of Physical Currency and Bearer Negotiable Instruments Bill

(LC Paper No. LS44/16-17)

- 3. At the invitation of the Chairman, <u>Legal Adviser</u> ("LA") briefed Members on the report prepared by the Legal Service Division ("LSD") on the Bill.
- 4. <u>Dr Helena WONG</u> considered it necessary to form a Bills Committee to study the Bill in detail. <u>Members</u> agreed. Dr Helena WONG agreed to join the proposed Bills Committee.
- (b) Legal Service Division report on subsidiary legislation gazetted on 24 February 2017 and tabled in Council on 1 March 2017 (LC Paper No. LS40/16-17)
- 5. At the invitation of the Chairman, <u>LA</u> briefed Members on the report prepared by LSD on three items of subsidiary legislation (i.e. L.N. 27 to L.N. 29) which were gazetted on 24 February 2017 and tabled in Council on 1 March 2017.
- 6. Mr WU Chi-wai considered it necessary to form a subcommittee to study the Copyright Tribunal Rules (L.N. 29) in detail. Members agreed. Mr WU Chi-wai and Mr Dennis KWOK agreed to join the proposed subcommittee. As the deadline for amending the Rules would be the Council meeting of 29 March 2017 unless extended by a resolution of the Council, Members also agreed that the Chairman should, in her capacity as the Chairman of the House Committee ("HC"), move a motion at the Council meeting of 22 March 2017 to extend the scrutiny period of the Rules to the Council meeting of 26 April 2017.
- 7. <u>Members</u> did not raise any question on the other two items of subsidiary legislation (i.e. L.N. 27 and L.N. 28). <u>The Chairman</u> reminded Members that the deadline for amending these two items of subsidiary legislation would be the Council meeting of 29 March 2017.

IV. Legal Service Division report on subsidiary legislation gazetted on 10 March 2017

- 8. At the invitation of the Chairman, <u>LA</u> briefed Members on the report prepared by LSD on three items of subsidiary legislation (i.e. the Road Tunnels (Government) (Amendment) Regulation 2017 (L.N. 34), the Tsing Ma Control Area (Tolls, Fees and Charges) (Amendment) Regulation 2017 (L.N. 35), and the Tsing Sha Control Area (Tolls, Fees and Charges) (Amendment) Regulation 2017 (L.N. 36)) which were gazetted on 10 March 2017 and would be tabled in Council on 22 March 2017.
- 9. <u>Mr Jeremy TAM</u> considered it necessary to form a subcommittee to study the three Amendment Regulations in detail. <u>Members</u> agreed. Mr Charles MOK, Dr KWOK Ka-ki and Mr Jeremy TAM agreed to join the subcommittee.
- 10. <u>Members</u> noted that the deadline for amending the three Amendment Regulations would be the Council meeting of 12 April 2017, or that of 10 May 2017 if extended by a resolution of the Council.

- 11. At the invitation of the Chairman, <u>LA</u> briefed Members on the report prepared by LSD on the Antiquities and Monuments (Declaration of Proposed Monument) (Hung Lau) Notice (L.N. 37) which was gazetted on 13 March 2017 and would be tabled in Council on 22 March 2017.
- 12. <u>Dr KWOK Ka-ki</u> considered it necessary to form a subcommittee to study the Notice in detail. <u>Members</u> agreed. Dr KWOK Ka-ki and Mr KWONG Chun-yu agreed to join the proposed subcommittee.
- 13. <u>Members</u> noted that the deadline for amending the Notice would be the Council meeting of 12 April 2017, or that of 10 May 2017 if extended by a resolution of the Council.

- 23. At the invitation of the Chairman, <u>LA</u> briefed Members on the report prepared by LSD on the above two proposed resolutions. <u>Members</u> did not raise any question and had no objection to the Administration moving the two proposed resolutions at the Council meeting of 29 March 2017.
 - (iii) Proposed resolution to be moved by the Secretary for Transport and Housing under section 23(3) of the Road Traffic Ordinance (Cap. 374)

(LC Paper No. CB(3)398/16-17) (LC Paper No. LS41/16-17)

24. At the invitation of the Chairman, <u>LA</u> briefed Members on the report prepared by LSD on the above proposed resolution. <u>Members</u> noted that the purpose of the proposed resolution was to seek the approval of the Legislative Council ("LegCo") to extend the effective period of the current statutory limit on the number of registered public light buses ("PLBs") at 4 350 for five years until 20 June 2022.

- In response to Mr James TO's enquiry about the mechanism for the 25. extension of the effective period of the statutory limit on the number of PLBs, LA advised that the total number of vehicles which might be registered as PLBs had been capped at 4 350 since 1976. The statutory limit was originally set out in the Public Light Buses (Limitation on Number) Notice (Cap. 374K) made by the Chief Executive in Council ("CE in Council") under section 23(1) of the Road Traffic Ordinance (Cap. 374). Pursuant to section 23(2) and (3) of Cap. 374, the limit so imposed by Cap. 374K should remain in force for such period not exceeding 12 months unless extended by a resolution of LegCo. effective period of such statutory limit had been extended from time to time through resolutions passed by LegCo, and it was last extended in 2011 for a period of five years up to 20 June 2016. The effective period of the statutory limit as stipulated in Cap. 374K, however, had not been further extended as the resolution proposed to be moved by the Secretary for Transport and Housing in 2016 for its extension was not dealt with by LegCo before its expiry on 20 June 2016. A fresh notice (i.e. the Road Traffic (Public Light Buses: Limit on Number) Notice 2016 (L.N. 101 of 2016)) had since been made by CE in Council to repeal Cap. 374K and impose the same statutory limit for 12 months up to 20 June 2017. subcommittee had been formed to study L.N. 101 of 2016.
- Mr James TO said that the Administration should provide 26. information on its latest review on the statutory limit on the number of PLBs, including any relevant assessment(s) conducted, to support its proposal to maintain the existing statutory limit. He enquired whether the Administration had provided any such information to LegCo. LEUNG Kwok-hung considered it necessary for LegCo to review the appropriateness of the existing statutory limit on the number of PLBs which had been in force since 1976. Dr Helena WONG said that it was her understanding that the Administration's proposal to extend the effective period of the existing statutory limit on the number of PLBs for another five years had not been discussed by the Panel on Transport in the She considered it necessary for the Administration current LegCo term. to provide information on whether any review on the existing statutory limit had been conducted and if so, the review outcome, so as to facilitate Members' consideration of whether the limit should be maintained. WONG suggested that a subcommittee be formed to study the proposed resolution in detail. Members raised no objection. Mr LEUNG Kwok-hung and Dr Helena WONG agreed to join the proposed subcommittee.

- 27. Mr Frankie YICK said that he recalled that the Panel on Transport had been briefed on issues relating to the statutory limit on the number of PLBs and members of the Panel supported maintaining the existing limit at 4 350. He suggested that the relevant paper(s) provided by the Administration to the Panel be circulated to Members for reference.
- 28. <u>The Chairman</u> informed Members that in line with the established practice and the arrangement agreed with the Administration, the Administration would be requested to withdraw its notice for moving the proposed resolution so as to allow sufficient time for the proposed subcommittee to carry out its scrutiny work. <u>The Chairman</u> further directed that to facilitate Members' consideration of whether to join the proposed subcommittee, the relevant paper(s) previously provided by the Administration to the Panel on Transport should be circulated to Members for reference.
