Purpose

3. The House Committee formed three subcommittees to study items (1) to (6), item (7), as well as item (8) respectively in detail at its meeting on 28 April 2017. The first Subcommittee reported its deliberations at the House Committee meeting on 2 June 2017 vide LC Paper No. CB(4)1114/16-17. The second and the third Subcommittees made verbal reports at the House Committee meeting on 2 June 2017 respectively, and provided Members with written reports vide LC Paper Nos. CB(2)1566/16-17 and CB(1)1087/16-17 on 7 June 2017 respectively.

4. In respect of item (9), the House Committee considered it not necessary to form a subcommittee to study this item of subsidiary legislation.

Note: The House Committee formed a subcommittee to study the following two items of subsidiary legislation at its meeting on 19 May 2017. The Council passed at its meeting of 7 June 2017 a resolution moved by Hon CHAN Chun-ying, Chairman of the Subcommittee, to extend the period for amending these two items of subsidiary legislation to the Council meeting of 5 July 2017.
